PRIOR COURSEWORK

IN ADDITION TO STANDARDIZED TEST SCORES, UCSD EVALUATES STUDENTS BASED ON THEIR PRIOR COURSEWORK. STUDENTS WHO HAVE TAKEN ECONOMICS OR MATHEMATICS COURSES AT THE HIGH SCHOOL LEVEL OR THROUGH OTHER INSTITUTIONS MAY RECEIVE CREDIT OR ADVANCED PLACEMENT IF THOSE COURSES MEET UCSD'S STANDARDS.

COURSE OFFERINGS AND STRUCTURE
