KEY ECONOMIC CONCEPTS COVERED

THE LAW OF DEMAND STATES THAT, ALL ELSE BEING EQUAL, AS THE PRICE OF A GOOD FALLS, THE QUANTITY DEMANDED RISES, AND VICE VERSA. CONVERSELY, THE LAW OF SUPPLY STATES THAT AN INCREASE IN PRICE RESULTS IN AN INCREASE IN THE QUANTITY SUPPLIED. STUDENTS WILL LEARN HOW TO GRAPH THESE CONCEPTS AND ANALYZE SHIFTS IN THE CURVES DUE TO VARIOUS FACTORS SUCH AS CONSUMER PREFERENCES, TECHNOLOGICAL ADVANCEMENTS, AND EXTERNAL EVENTS.

MARKET STRUCTURES

STUDENTS WILL ALSO EXPLORE DIFFERENT MARKET STRUCTURES, INCLUDING:

- PERFECT COMPETITION
- MONOPOLISTIC COMPETITION
- OLIGOPOLY
- MONOPOLY

EACH STRUCTURE HAS UNIQUE CHARACTERISTICS AND IMPLICATIONS FOR PRICING, OUTPUT, AND CONSUMER CHOICE. UNDERSTANDING THESE DIFFERENCES IS VITAL FOR ANALYZING BUSINESS STRATEGIES AND MARKET DYNAMICS.
