- **CONSUMER INCOME:** AN INCREASE IN INCOME GENERALLY INCREASES DEMAND FOR NORMAL GOODS.
- **CONSUMER PREFERENCES:** CHANGES IN TASTES AND PREFERENCES CAN LEAD TO CHANGES IN DEMAND.
- **PRICES OF RELATED GOODS:** THE DEMAND FOR A PRODUCT MAY BE AFFECTED BY THE PRICE CHANGES OF SUBSTITUTES AND COMPLEMENTS.
- **FUTURE EXPECTATIONS:** EXPECTATIONS OF FUTURE PRICE CHANGES CAN INFLUENCE CURRENT DEMAND.

QUESTION 2: EXPLAIN THE CONCEPT OF ELASTICITY OF DEMAND.

ELASTICITY OF DEMAND MEASURES HOW THE QUANTITY DEMANDED OF A GOOD RESPONDS TO A CHANGE IN PRICE. IT IS CALCULATED AS THE PERCENTAGE CHANGE IN QUANTITY DEMANDED DIVIDED BY THE PERCENTAGE CHANGE IN PRICE. THERE ARE THREE TYPES OF ELASTICITY:

- **PRICE ELASTICITY OF DEMAND:** MEASURES RESPONSIVENESS TO PRICE CHANGES.
- **INCOME ELASTICITY OF DEMAND:** MEASURES RESPONSIVENESS TO CHANGES IN CONSUMER INCOME.
- **CROSS ELASTICITY OF DEMAND:** MEASURES RESPONSIVENESS TO CHANGES IN THE PRICE OF RELATED GOODS.

UNDERSTANDING ELASTICITY HELPS BUSINESSES SET PRICES AND PREDICT HOW CHANGES WILL AFFECT THEIR SALES.

EFFECTIVE STUDY STRATEGIES FOR ECONOMICS

A: CONSUMER INCOME AFFECTS DEMAND; TYPICALLY, AS INCOME INCREASES, DEMAND FOR NORMAL GOODS RISES, WHILE DEMAND FOR INFERIOR GOODS MAY FALL.

Q: CAN YOU EXPLAIN THE CONCEPT OF MARKET STRUCTURES?

A: MARKET STRUCTURES REFER TO THE ORGANIZATIONAL AND COMPETITIVE CHARACTERISTICS OF A MARKET, INCLUDING TYPES SUCH AS PERFECT COMPETITION, MONOPOLISTIC COMPETITION, OLIGOPOLY, AND MONOPOLY.

Q: WHAT IS THE LAW OF DEMAND?

A: THE LAW OF DEMAND STATES THAT, ALL ELSE BEING EQUAL, AS THE PRICE OF A GOOD RISES, THE QUANTITY DEMANDED DECREASES, AND VICE VERSA.

Q: HOW DO RELATED GOODS AFFECT DEMAND?

A: THE DEMAND FOR A PRODUCT CAN BE INFLUENCED BY THE PRICE CHANGES OF SUBSTITUTES (GOODS THAT CAN REPLACE EACH OTHER) AND COMPLEMENTS (GOODS THAT ARE CONSUMED TOGETHER).

Q: WHY IS PASSING THE WAEC ECONOMICS EXAM IMPORTANT?

A: PASSING THE WAEC ECONOMICS EXAM IS IMPORTANT FOR GAINING ADMISSION INTO HIGHER EDUCATION PROGRAMS AND FOR DEVELOPING CRITICAL THINKING SKILLS ESSENTIAL FOR VARIOUS PROFESSIONAL FIELDS.
