DEFINITION OF PURCHASING POWER PARITY

THUS, IF A BASKET OF GOODS COSTS 100 UNITS OF CURRENCY IN ONE COUNTRY, IT SHOULD COST THE EQUIVALENT AMOUNT IN ANOTHER COUNTRY WHEN TAKING THE EXCHANGE RATE INTO ACCOUNT.

THE PRINCIPLE OF PPP CAN BE ILLUSTRATED THROUGH THE “LAW OF ONE PRICE,” WHICH STATES THAT IN AN EFFICIENT MARKET, ALL IDENTICAL GOODS MUST HAVE ONLY ONE PRICE WHEN EXPRESSED IN A COMMON CURRENCY. THIS CONCEPT IS USED TO UNDERSTAND HOW DIFFERENT ECONOMIES CAN BE COMPARED IN TERMS OF THEIR PURCHASING POWER, ALLOWING FOR MORE ACCURATE ECONOMIC ANALYSIS ACROSS BORDERS.

THE SIGNIFICANCE OF PPP IN ECONOMICS

How is PPP Calculated?
