DEFINITION OF CONGLOMERATE

DIVERSIFICATION

- **PRODUCT DIVERSIFICATION:** OFFERING A WIDE RANGE OF PRODUCTS ACROSS DIFFERENT INDUSTRIES.
- **GEOGRAPHICAL DIVERSIFICATION:** OPERATING IN MULTIPLE REGIONS OR COUNTRIES TO TAP INTO VARIOUS MARKETS.

MULTI-INDUSTRY OPERATIONS

COMPLEX ORGANIZATIONAL STRUCTURE

DUE TO THEIR DIVERSE OPERATIONS, CONGLOMERATES OFTEN HAVE A COMPLEX ORGANIZATIONAL STRUCTURE. THIS STRUCTURE MAY INCLUDE VARIOUS SUBSIDIARIES, DIVISIONS, AND AFFILIATED COMPANIES, EACH FOCUSING ON SPECIFIC MARKETS OR PRODUCTS.
