THE BEST DEFINITIONS OF ECONOMICS OFTEN EMPHASIZE THE RELATIONSHIP BETWEEN HUMAN WANTS AND AVAILABLE RESOURCES. IN THIS CONTEXT, ECONOMICS IS NOT JUST ABOUT MONEY; IT INVOLVES A WIDE RANGE OF ACTIVITIES AND DECISIONS THAT AFFECT WELL-BEING AND SOCIETAL PROGRESS.

## KEY DEFINITIONS

- **ALFRED MARSHALL:** MARSHALL OFFERED A BROADER PERSPECTIVE, DEFINING ECONOMICS AS THE STUDY OF MANKIND IN THE ORDINARY BUSINESS OF LIFE, EMPHASIZING ITS SOCIAL DIMENSIONS.
- **SCARCITY AND CHOICE:** A CONTEMPORARY DEFINITION HIGHLIGHTS THAT ECONOMICS IS THE STUDY OF HOW INDIVIDUALS

AND SOCIETIES CHOOSE TO ALLOCATE SCARCE RESOURCES AMONG COMPETING USES.

## THE CORE PRINCIPLES OF ECONOMICS

### SCARCITY

### OPPORTUNITY COST

OPPORTUNITY COST IS ANOTHER FUNDAMENTAL PRINCIPLE. IT REPRESENTS THE VALUE OF THE NEXT BEST ALTERNATIVE FOREGONE WHEN MAKING A DECISION. UNDERSTANDING OPPORTUNITY COSTS HELPS INDIVIDUALS AND BUSINESSES MAKE INFORMED DECISIONS ABOUT RESOURCE ALLOCATION.

### SUPPLY AND DEMAND

SUPPLY AND DEMAND ARE CRUCIAL CONCEPTS THAT EXPLAIN HOW MARKETS FUNCTION. THE LAW OF DEMAND STATES THAT, ALL ELSE BEING EQUAL, AS THE PRICE OF A GOOD DECREASES, THE QUANTITY DEMANDED INCREASES.
