METHODS OF ESTIMATION

4. DATA ANALYSIS

IN FIELDS LIKE STATISTICS AND DATA SCIENCE, ESTIMATION TECHNIQUES ARE CRUCIAL FOR MAKING PREDICTIONS AND DRAWING CONCLUSIONS FROM DATA SETS. THIS IS PARTICULARLY IMPORTANT IN PREDICTIVE MODELING AND MACHINE LEARNING.
