IN MATHEMATICAL EXPRESSIONS, THE ORDER OF OPERATIONS DETERMINES WHICH CALCULATIONS ARE CARRIED OUT FIRST. FOR INSTANCE, IN THE EXPRESSION $3 + 5 \times 2$, THE MULTIPLICATION IS PERFORMED BEFORE THE ADDITION, LEADING TO A DIFFERENT RESULT THAN IF THE OPERATIONS WERE PERFORMED FROM LEFT TO RIGHT. THIS PRINCIPLE IS FOUNDATIONAL NOT ONLY IN BASIC ARITHMETIC BUT ALSO IN HIGHER-LEVEL MATHEMATICS, INCLUDING ALGEBRA AND CALCULUS.

THE ORDER OF OPERATIONS EXPLAINED

THE ORDER OF OPERATIONS IS A SET OF RULES THAT DICTATES THE SEQUENCE IN WHICH OPERATIONS ARE EXECUTED IN A MATHEMATICAL EXPRESSION. - **M: MULTIPLICATION** - CARRY OUT MULTIPLICATION FROM LEFT TO RIGHT.
- **D: DIVISION** - PERFORM DIVISION FROM LEFT TO RIGHT.
- **A: ADDITION** - EXECUTE ADDITION FROM LEFT TO RIGHT.
- **S: SUBTRACTION** - COMPLETE SUBTRACTION FROM LEFT TO RIGHT.

TO ILLUSTRATE THIS FURTHER, CONSIDER THE EXPRESSION $6 + (5 - 3) \times 2$. ACCORDING TO THE ORDER OF OPERATIONS, WE FIRST RESOLVE THE PARENTHESES: $(5 - 3)$ EQUALS 2. NEXT, WE MULTIPLY, RESULTING IN 2×2 , WHICH GIVES US 4. FINALLY, WE ADD $6 + 4$, YIELDING A FINAL ANSWER OF 10. THIS SYSTEMATIC APPROACH TO SOLVING EXPRESSIONS IS ESSENTIAL TO AVOID MISTAKES.

RULES GOVERNING MATH FUNCTIONS ORDER

WHILE THE ACRONYM PEMDAS SERVES AS A HELPFUL MNEMONIC, THERE ARE ADDITIONAL NUANCES AND RULES TO CONSIDER WHEN APPLYING THE ORDER OF OPERATIONS. HERE ARE SOME ESSENTIAL GUIDELINES:

- **EXECUTE ADDITION AND SUBTRACTION FROM LEFT TO RIGHT:** SIMILAR TO MULTIPLICATION AND DIVISION, THESE OPERATIONS SHOULD ALSO BE PERFORMED IN THE ORDER THEY APPEAR.

UNDERSTANDING THESE RULES ALLOWS FOR ACCURATE CALCULATIONS AND HELPS IN RECOGNIZING HOW DIFFERENT OPERATIONS INTERACT WITHIN EXPRESSIONS. FOR INSTANCE, IN THE EXPRESSION $8 \div 2 \times 4$, WE FIRST DIVIDE 8 BY 2 TO GET 4, AND THEN MULTIPLY BY 4, RESULTING IN 16. IF WE MISAPPLIED THE ORDER AND PERFORMED THE MULTIPLICATION FIRST, WE WOULD INCORRECTLY ARRIVE AT 32.

COMMON MISTAKES IN MATH FUNCTIONS ORDER

EVEN EXPERIENCED INDIVIDUALS CAN SOMETIMES MAKE MISTAKES WHEN IT COMES TO MATH FUNCTIONS ORDER. SOME COMMON PITFALLS INCLUDE:
