- **Step 3: Hundreds Place**

Finally, we move to the hundreds place. We originally had 3 hundreds, but we borrowed 1, so we now have 2 hundreds. We need to subtract 1 from 2. This is straightforward: $2 - 1 = 1$. We write down 1 in the hundreds place of our answer.

The final answer is 175. This example clearly demonstrates how regrouping allows us to handle subtractions that would otherwise be impossible within a single place value.

When Addition Regrouping Becomes More Complex
