Reflection: Mirroring Figures

A reflection is like looking at a shape in a mirror. It flips the shape over a line, called the line of reflection. The reflected image is a mirror image of the original, with the line of reflection acting as the mirror. Rotation: Turning Shapes

Dilation: Resizing Geometric Objects
