Dilation with a Scale Factor Greater Than 1

When the scale factor k is greater than 1 (e.g., $k = 2$, $k = 3.5$), the dilation results in an enlargement. The dilated figure will be larger than the original figure. All distances from the center of dilation to points on the figure are increased by a factor of k . This is the most intuitive form of dilation, akin to looking through a magnifying glass.

For instance, if we have a triangle with vertices $A(1,1)$, $B(3,1)$, and $C(1,3)$, and we dilate it with a scale factor of 2 from the origin $(0,0)$, the new vertices will be $A'(2,2)$, $B'(6,2)$, and $C'(2,6)$. Notice how each coordinate is doubled. The side lengths of the original triangle are $AB=2$, $AC=2$, and $BC = \sqrt{(3-1)^2 + (1-3)^2} = \sqrt{4+4} = \sqrt{8}$. The side lengths of the dilated triangle are $A'B'=4$, $A'C'=4$, and $B'C' = \sqrt{(6-2)^2 + (2-6)^2} = \sqrt{16+16} = \sqrt{32}$. You can see that $4 = 2 \cdot 2$ and $\sqrt{32} = \sqrt{8} \cdot 2$, confirming the linear scaling.

Dilation with a Scale Factor Between 0 and 1

If the scale factor k is between 0 and 1 (e.g., $k = 0.5$, $k = 0.25$), the dilation results in a reduction or shrinkage. The dilated figure will be smaller than the original figure. Distances from the center of dilation to points on the figure are decreased by a factor of k . This is like looking at an object from a greater distance or using a telephoto lens to make it appear smaller.

Consider our triangle again with vertices $A(1,1)$, $B(3,1)$, and $C(1,3)$. If we dilate it with a scale factor of 0.5 from the origin, the new vertices become $A'(0.5, 0.5)$, $B'(1.5, 0.5)$, and $C'(0.5, 1.5)$. Each original coordinate is multiplied by 0.5. The side lengths of the original triangle were 2, 2, and $\sqrt{8}$. The new side lengths are $A'B'=1$, $A'C'=1$, and $B'C' = \sqrt{(1.5-0.5)^2 + (0.5-1.5)^2} = \sqrt{1+1} = \sqrt{2}$. Indeed, $1 = 0.5 \cdot 2$ and $\sqrt{2} = \sqrt{8} \cdot 0.5$, demonstrating the shrinking effect.

Dilation with a Scale Factor of 1

A scale factor of exactly 1 ($k = 1$) results in a dilation that doesn't change the size of the figure at all. In this case, the dilated image is congruent to the original figure. Every point in the original figure remains in the same position in the dilated figure. Mathematically, multiplying any coordinate by 1 leaves it unchanged, hence $x' = 1x = x$ and $y' = 1y = y$.

This might seem trivial, but it's important to note that a dilation with a scale factor of 1 is still considered a dilation. It's a special case where the enlargement or reduction factor is neutral. This means that if a shape can be dilated onto itself (as with a rotation or translation that maps it onto itself), it's technically a dilation with a scale factor of 1 relative to its center of symmetry, though other transformations might be more descriptive.

Dilation with a Negative Scale Factor

What happens when the scale factor is negative (e.g., $k = -2$, $k = -0.5$)? A negative scale factor indicates not only a change in size but also a reflection through the center of dilation. The dilated figure will be on the opposite side of the center of dilation compared to the original figure, and it will be inverted.

If we take our triangle with vertices $A(1,1)$, $B(3,1)$, and $C(1,3)$ and dilate it with a scale factor of -2 from the origin, the new vertices become $A'(-2, -2)$, $B'(-6, -2)$, and $C'(-2, -6)$. Notice that each coordinate is multiplied by -2 . The resulting triangle is larger (twice the linear dimensions) but is located in the third quadrant, diametrically opposite to the original figure's location in the first quadrant, relative to the origin. This combination of scaling and reflection is a key characteristic of negative scale factors.
