- **Record & Repeat:** We have a remainder of 6. Can 12 go into 6? No, because 6 is smaller than 12. So, our last partial quotient is 6.
- **Sum:** Add the partial quotients: $50 + 6 = 56$. Our remainder is 6. So, $678 \div 12 = 56$ with a remainder
