HISTORICAL CONTEXT

THE ROOTS OF EVERETT PHYSICS CAN BE TRACED BACK TO THE EARLY 20TH CENTURY, A TIME WHEN QUANTUM MECHANICS BEGAN TO CHALLENGE CLASSICAL PHYSICS. HUGH EVERETT III'S CONTRIBUTION

IN 1957, HUGH EVERETT III PROPOSED HIS MANY-WORLDS INTERPRETATION AS A RESPONSE TO THE PHILOSOPHICAL CHALLENGES POSED BY THE COPENHAGEN INTERPRETATION. HE SUGGESTED THAT EVERY QUANTUM EVENT CREATES A BRANCHING OF THE UNIVERSE INTO MULTIPLE OUTCOMES, EACH REPRESENTING A DIFFERENT POSSIBILITY. THIS RADICAL IDEA WAS INITIALLY MET WITH SKEPTICISM AND LARGELY IGNORED UNTIL THE LATE 20TH CENTURY, WHEN IT GAINED TRACTION AMONG PHYSICISTS AND PHILOSOPHERS ALIKE.

THE MANY-WORLDS INTERPRETATION

THE MANY-WORLDS INTERPRETATION IS THE CORNERSTONE OF EVERETT PHYSICS. IT PROPOSES THAT ALL POSSIBLE OUTCOMES OF QUANTUM MEASUREMENTS ARE REALIZED, LEADING TO A VAST MULTIVERSE OF PARALLEL REALITIES. THIS SECTION DELVES

MATHEMATICAL FRAMEWORK

CAUSALITY, A FUNDAMENTAL PRINCIPLE IN SCIENCE, IS ALSO AFFECTED BY THE MANY-WORLDS INTERPRETATION. IN THIS FRAMEWORK, ACTIONS AND DECISIONS ARE NOT SINGULAR EVENTS BUT RATHER PART OF A BROADER TAPESTRY OF OUTCOMES. THIS UNDERSTANDING RESHAPES HOW WE PERCEIVE CAUSE AND EFFECT, SUGGESTING THAT OUR CHOICES RESONATE ACROSS MULTIPLE REALITIES.

CRITICISMS OF EVERETT PHYSICS

DESPITE ITS INTRIGUING PROPOSITIONS, EVERETT PHYSICS HAS FACED CRITICISM FROM VARIOUS QUARTERS. THIS SECTION EXAMINES THE MAIN OBJECTIONS RAISED AGAINST THE MANY-WORLDS INTERPRETATION.
