REAL-WORLD PHYSICS OBJECTS

THE DISTINCTION BETWEEN MASS AND WEIGHT IS VITAL IN PHYSICS, ESPECIALLY WHEN STUDYING MOTION AND FORCES.

VOLUME AND DENSITY

VOLUME REFERS TO THE AMOUNT OF SPACE AN OBJECT OCCUPIES, WHILE DENSITY IS THE MASS PER UNIT VOLUME. THESE CHARACTERISTICS ARE ESSENTIAL FOR UNDERSTANDING BUOYANCY, FLOW, AND PHYSICAL INTERACTIONS IN FLUIDS. FOR EXAMPLE, KNOWING THE DENSITY OF AN OBJECT HELPS PREDICT WHETHER IT WILL FLOAT OR SINK IN A LIQUID.

APPLICATIONS OF PHYSICS OBJECTS
