where v_{y0} is the initial vertical velocity and y is the vertical displacement.

Resolving Initial Velocity

If a projectile is launched with an initial speed v_0 at an angle θ above the horizontal, its initial velocity can be resolved into its components using trigonometry. The initial horizontal velocity is $v_{x0} = v_0 \cos(\theta)$, and the initial vertical velocity is $v_{y0} = v_0 \sin(\theta)$. This formula shows that the maximum height is directly proportional to the square of the initial vertical velocity and inversely proportional to the acceleration due to gravity.

Horizontal Range Calculation

The horizontal range (R) is the total horizontal distance the projectile travels before returning to its initial launch height. To find the range, we first need to determine the total time of flight (T). For a projectile launched and landing at the same height, the time it takes to reach its maximum height is $t_{\text{up}} = \frac{v_{y0}}{g}$. The total time of flight is twice this, so $T = 2t_{\text{up}} = \frac{2v_{y0}}{g}$. The horizontal range is then calculated by multiplying the constant horizontal velocity by the total time of flight: $R = v_{x0}T$. Substituting the expressions for v_{x0} and T , we get $R = (v_0 \cos(\theta)) \left(\frac{2v_0 \sin(\theta)}{g} \right) = \frac{v_0^2 (2 \sin(\theta) \cos(\theta))}{g}$. Using the trigonometric identity $(2 \sin(\theta) \cos(\theta) = \sin(2\theta))$, the range formula simplifies to $R = \frac{v_0^2 \sin(2\theta)}{g}$.
