How is the Impact Factor Calculated?

The formula can be represented as:

- $\text{Impact Factor (Year X)} = \frac{\text{Citations in Year X to articles published in Year X-1 and Year X-2}}{\text{(Total number of citable items published in Year X-1 and Year X-2)}}$
