In simpler terms, if you start at a point in a series circuit and traverse the entire loop, returning to your starting point, the total voltage you gain from the power source must be equal to the total voltage you "lose" or drop across the circuit's components. This law underscores the conservation of energy within an electrical circuit.

Furthermore, adding more components in series generally increases the total resistance, which can be beneficial in applications where it's desirable to limit the overall current flow from a power source, thus protecting the source from overload.

This interdependence makes series circuits less reliable for applications where continuous operation is a priority and where the failure of one part shouldn't impact others.

Voltage Drop Across Each Component

While this design is prone to failure, it was cost-effective and allowed for the use of low-voltage bulbs powered by standard household mains voltage by distributing the voltage drop across multiple bulbs.
