This allows for the calculation of potential energy changes when charges are moved within electric fields.

Capacitance, a key concept in this section, quantifies a device's ability to store electrical charge. A capacitor consists of two conductive plates separated by an insulating dielectric material. The capacitance is defined as the ratio of the charge stored on each plate to the potential difference between them. Students will explore how factors like the area of the plates, the distance between them, and the dielectric constant of the material affect capacitance. They will also learn to analyze circuits with capacitors, including series and parallel combinations, and calculate the energy stored in a capacitor. This knowledge is vital for understanding electronic circuits and energy storage systems.

## **DC Circuits and Analysis**

Direct current (DC) circuits form a significant part of the Physics 206 curriculum. This involves the study of electric current, which is the flow of electric charge, and the devices that facilitate and control this flow. Using these rules, students can systematically solve for unknown currents and voltages in intricate circuit configurations. The course also covers the power dissipated in circuits, allowing for calculations of energy consumption and heat generation.

## **Magnetism and Magnetic Fields**

The journey into magnetism introduces students to another fundamental force of nature. This section begins with the definition of magnetic fields, which are regions of space where magnetic forces can be detected. Unlike electric charges, which can exist in isolation, magnetic poles (north and south) always come in pairs. Students will study the magnetic forces exerted on moving charges, described by the Lorentz force law, and the forces experienced by current-carrying wires in magnetic fields.

Key laws for calculating magnetic fields are introduced, including the Biot-Savart Law, which allows for the calculation of the magnetic field produced by a small segment of current-carrying wire, and Ampere's Law, which provides a more convenient method for calculating magnetic fields in situations

with high symmetry, similar to Gauss's Law in electrostatics. Understanding the right-hand rules is essential for determining the direction of magnetic fields and forces. The magnetic field of solenoids and toroids are often examined as important practical applications.

## **Electromagnetic Induction and Maxwell's Equations**

Electromagnetic induction is the phenomenon where a changing magnetic field can induce an electromotive force (EMF), and thus a current, in a conductor. Faraday's Law of induction is the fundamental principle here, quantifying the induced EMF as being proportional to the rate of change of magnetic flux through a surface. Lenz's Law provides the direction of the induced current, always opposing the change in magnetic flux that produced it. This concept is crucial for understanding generators, transformers, and many other electrical technologies.

The culmination of the introductory electromagnetism sequence is Maxwell's Equations. These four elegant equations unify electricity and magnetism, describing the behavior of electric and magnetic fields and their interactions with charges and currents. They form the foundation for classical electrodynamics and predict the existence of electromagnetic waves, such as radio waves, microwaves, and light, traveling at the speed of light. Understanding Maxwell's Equations, even at an introductory level, provides profound insight into the nature of light and the universe.
