Adhesion: Water Sticking to Other Things

Adhesion, on the other hand, is the attraction between molecules of different substances. Water exhibits strong adhesion to many polar or charged surfaces, such as glass, metal, and plant tissues. This property is responsible for capillary action. When a narrow tube is placed in water, the adhesive forces between the water molecules and the tube's walls pull the water molecules up the sides of the tube. Due to cohesion, this upward pull is transmitted to the rest of the water column, causing it to rise against gravity.

The Flow of Life: Understanding Viscosity

Viscosity is a measure of a fluid's resistance to flow. Think of it as the internal friction within a liquid. Honey, with its thick, syrupy consistency, has high viscosity, while water flows much more easily and thus has lower viscosity.
