The Piezoelectric Principle Explained

As mentioned earlier, transducer frequency is a direct result of the piezoelectric crystal's properties and thickness. Higher frequencies mean shorter wavelengths, which is beneficial for imaging small, superficial structures with high detail. Lower frequencies, with longer wavelengths, are better for penetrating deeper into the body.

The Interplay of Frequency, Wavelength, and Speed

The relationship between frequency (f), wavelength (λ), and the speed of

sound (c) in a medium is a fundamental equation in wave physics: $c = f\lambda$. This simple formula tells us a lot about ultrasound propagation. In diagnostic ultrasound, the speed of sound in soft tissue is remarkably consistent, averaging around 1540 meters per second (m/s), or 1.54 millimeters per microsecond (mm/ μ s). This constancy is a crucial assumption that ultrasound machines rely on for accurate depth measurements. The machine assumes sound travels at this speed and calculates the depth of a reflecting structure based on the time it takes for the echo to return. If the sound speed in a particular tissue deviates significantly from this average, it can lead to depth miscalculations and image distortion.

Given the relatively constant speed of sound in tissue, frequency and wavelength are inversely proportional. If you increase the frequency, the wavelength decreases, and vice versa. For example, an ultrasound transducer operating at 5 MHz will produce waves with a longer wavelength than one operating at 10 MHz. This inverse relationship is key to understanding resolution. Shorter wavelengths (higher frequencies) are better able to resolve small objects because they can interact with structures that are similar in size to their wavelength. Conversely, longer wavelengths (lower frequencies) can "pass over" small structures, making them difficult to discern. This is why high-frequency transducers are used for superficial structures like the thyroid or small blood vessels, while lower-frequency transducers are preferred for deeper organs like the liver or kidneys.

Speed of Sound in Different Tissues

While we often use an average speed of sound for soft tissue, it's important to recognize that the speed can vary slightly depending on the tissue composition. For instance, the speed of sound in bone is significantly higher than in soft tissue, approximately 3500 m/s. This difference in speed is one reason why bone can attenuate ultrasound waves and create acoustic shadows. Fat has a slightly lower speed of sound than muscle, and fluid (like in a cyst) generally has a speed close to that of soft tissue. Air, however, presents a major challenge for ultrasound. Because air is a gas and has very different acoustic properties from tissue, it strongly reflects and scatters ultrasound waves, making it impossible to image through.

These variations in the speed of sound can subtly affect image quality. For example, if an ultrasound beam passes through a region of tissue with a significantly slower or faster speed of sound than assumed, the image can become distorted. The machine might miscalculate the depth of structures located beyond that region. Modern ultrasound systems employ sophisticated algorithms to compensate for some of these speed variations, but understanding the basic principles helps interpret any imaging anomalies. It's a reminder that while ultrasound is powerful, it operates within the physical constraints of the tissues it's imaging.

The casing of the transducer is also designed to protect these delicate components and to ensure proper acoustic coupling with the patient's skin.

Types of Transducer Arrays

The arrangement of piezoelectric elements within a transducer is categorized into different array types, each with distinct imaging capabilities. The most common types include linear arrays, curved arrays (also called convex or curvilinear arrays), and phased arrays. Linear array transducers have piezoelectric elements arranged in a straight line. This "phasing" allows for the creation of a narrow, pie-shaped sector image, which is particularly useful for imaging between the ribs (cardiac imaging) or in areas where a wider footprint transducer cannot be placed easily. The ability to steer the beam without physically moving the transducer is a significant advantage for dynamic imaging.

Beamforming and Focusing Techniques

Beamforming is the process by which the ultrasound system electronically controls the piezoelectric elements to shape and direct the ultrasound beam. When ultrasound waves encounter a boundary between two different media, what happens next – whether the sound is reflected back or transmitted forward – is largely determined by a property called acoustic impedance. Acoustic impedance (Z) is an intrinsic characteristic of a material that represents its resistance to the passage of sound waves. It is defined as the product of the material's density (ρ) and the speed of sound (c) within that material: $Z = \rho c$. Understanding acoustic impedance is fundamental to comprehending how ultrasound images are formed and why certain structures appear as they do.

When an ultrasound wave traveling in one medium strikes an interface with another medium, a portion of the wave's energy will be reflected, and a portion will be transmitted. The amount of reflection and transmission

depends on the difference in acoustic impedance between the two media. A large difference in acoustic impedance between two adjacent tissues results in a strong reflection (a bright echo on the image), while a small difference results in weaker reflection and more transmission of the sound wave into the second medium. This principle is the very foundation of how ultrasound creates an image; it's all about detecting these reflections.

The Reflection and Transmission Principle

Imagine an ultrasound wave encountering the boundary between two tissues, Tissue A and Tissue B, with different acoustic impedances, Z_A and Z_B . When the wave hits this interface, the amplitude of the reflected wave (R) and the transmitted wave (T) can be calculated. A key concept here is the reflection coefficient, which is related to the impedance mismatch. If Z_A is very different from Z_B , a large portion of the sound wave will be reflected. For example, the interface between soft tissue and bone has a significant acoustic impedance mismatch. Bone is dense and has a high speed of sound, leading to a high acoustic impedance. Therefore, a very strong echo is reflected from the bone surface, and very little sound is transmitted deeper into the bone. This is why bone often appears very bright (hyperechoic) and can cast an acoustic shadow.

Conversely, if Z_A is very close to Z_B , there will be only a small impedance mismatch, resulting in minimal reflection and significant transmission of the sound wave. This is why structures like cysts, which are filled with fluid that has an acoustic impedance very similar to surrounding soft tissue, appear anechoic (black). The sound wave passes through the cyst with little reflection, and the bright echoes seen from the posterior wall of the cyst are primarily due to the reflection from the posterior tissue boundary, which is then transmitted through the fluid. Understanding these impedance differences allows us to interpret the brightness of structures on an ultrasound image.

Acoustic Properties of Biological Tissues

Different biological tissues have distinct acoustic impedances due to variations in their density and the speed of sound they support. Soft tissues like muscle, liver, and kidney generally have similar acoustic impedances, typically around $1.63 \times 10^6 \text{ kg}/(\text{m}^2 \cdot \text{s})$. This similarity means that the interfaces between these organs are not strongly reflective, and ultrasound waves can penetrate them relatively well. This is why we can often see the internal texture of organs like the liver and kidneys clearly.

However, there are important exceptions. Bone, as mentioned, has a much higher acoustic impedance. Air has an extremely low acoustic impedance compared to tissue, and it poses a significant barrier to ultrasound

transmission. Fat has a slightly lower acoustic impedance than muscle. Blood also has an acoustic impedance very close to that of soft tissue. These differences are crucial for diagnostic interpretation. For instance, a mass that has a different acoustic impedance than the surrounding tissue will produce a noticeable echo pattern, helping to characterize its nature. The ability of ultrasound to differentiate between tissues is directly related to their differing acoustic impedance values.
