Q: Is it possible to do research in biophysics or interdisciplinary areas?

A: Absolutely. UC Berkeley has a strong and growing biophysics and interdisciplinary physics group. Many faculty members in this area collaborate across departments, offering diverse research opportunities that bridge physics with biology, chemistry, and engineering.

Q: What is the cost of attendance for a UC Berkeley Physics PhD student?

A: For domestic and international PhD students in good academic standing, tuition, fees, and health insurance are typically covered by the department through fellowships, teaching assistantships, and research assistantships. Students also receive a stipend for living expenses.
