## Understanding Wave Propagation and Key Parameters

This means that for every centimeter the beam travels and for every megahertz of frequency, a certain amount of intensity is lost. The total attenuation (A) can be calculated using the formula:  **$A = \text{attenuation coefficient} \times \text{depth} \times \text{frequency}$** . A common rule of thumb for soft tissue is an attenuation of approximately 0.5 dB/cm/MHz, meaning a 5 MHz transducer will lose about 2.5 dB of intensity for every centimeter it travels.

## Backscatter and Reflection Coefficients

When an ultrasound wave encounters an interface between two tissues with different acoustic impedances, a portion of the wave is reflected back

towards the transducer. The acoustic impedance ( $Z$ ) of a medium is the product of its density ( $\rho$ ) and the speed of sound ( $c$ ) in that medium:  $Z = \rho c$ . If the beam is parallel to the flow ( $\theta = 0^\circ$ ),  $\cos\theta = 1$ , and the measured velocity is the true velocity. If the beam is perpendicular to the flow ( $\theta = 90^\circ$ ),  $\cos\theta = 0$ , resulting in a zero frequency shift, rendering flow undetectable. Therefore, accurate angle correction is paramount in Doppler ultrasound to obtain meaningful velocity measurements. The formula for velocity can be rearranged to:  $v = (c\Delta f) / (2f_0 \cos\theta)$ . This highlights the importance of keeping the angle of insonation as small as possible, ideally less than 60 degrees.

## Power Doppler and Color Doppler
