Work Done by Electric Fields

Conversely, moving a positive charge from lower to higher potential requires external work against the electric field, increasing its potential energy. Capacitance and Dielectrics

Capacitance is a measure of a conductor's ability to store electric charge. DC Circuits and Kirchhoff's Rules

in parallel (across the same two points) is fundamental to circuit analysis. In a series connection, the equivalent resistance is the sum of individual resistances, and the current is the same through each resistor. In a parallel connection, the reciprocal of the equivalent resistance is the sum of the reciprocals of individual resistances, and the voltage is the same across each resistor. These concepts simplify complex resistor networks into single equivalent resistors.

Magnetic Fields and Forces

The next major domain explored in University Physics 2 is magnetism. Magnetic fields are generated by moving electric charges (electric currents) and by intrinsic magnetic moments of elementary particles. Magnetic fields exert forces on moving charges. The Biot-Savart Law describes how to calculate the magnetic field produced by a small segment of current-carrying wire. This law is the magnetic equivalent of Coulomb's Law for electric fields. We also study Ampere's Law, which, like Gauss's Law for electricity, provides a simpler way to calculate magnetic fields in situations with high symmetry, relating the line integral of the magnetic field around a closed loop to the total current passing through the loop.

Maxwell's Equations and Electromagnetic Waves
