UNDERSTANDING BLACKBODY RADIATION ALLOWS US TO DELVE INTO THE MYSTERIES OF STARLIGHT, THE HEAT WE FEEL FROM A STOVE, AND EVEN THE VERY ORIGINS OF THE UNIVERSE THROUGH THE COSMIC MICROWAVE BACKGROUND RADIATION. THIS ARTICLE WILL EXPLORE THE DEFINING CHARACTERISTICS OF A BLACKBODY, ITS SPECTRAL DISTRIBUTION, THE GROUNDBREAKING LAWS IT HELPED REVEAL, AND ITS PROFOUND IMPLICATIONS ACROSS VARIOUS SCIENTIFIC DISCIPLINES.

FREQUENTLY ASKED QUESTIONS ABOUT BLACKBODIES

WHAT IS A BLACKBODY? THE IDEAL ABSORBER AND EMITTER

AT ITS CORE, A BLACKBODY IS AN ABSTRACT, THEORETICAL OBJECT DEFINED BY ITS PERFECT ABSORPTIVE AND EMISSIVE PROPERTIES. IT'S A SCIENTIFIC IDEALIZATION, A PERFECT SCENARIO THAT HELPS US BUILD A ROBUST FRAMEWORK FOR UNDERSTANDING THERMAL RADIATION. WHEN ELECTROMAGNETIC RADIATION, IN ANY FORM – VISIBLE LIGHT, INFRARED, ULTRAVIOLET, X-RAYS, ETC. – STRIKES A BLACKBODY, IT IS COMPLETELY ABSORBED. NOT A SINGLE PHOTON IS REFLECTED BACK, AND NONE PASSES THROUGH. THIS ABSOLUTE ABSORPTION IS THE DEFINING TRAIT. HOWEVER, THE STORY DOESN'T END WITH ABSORPTION. A BLACKBODY IS ALSO A PERFECT EMITTER. AT ANY GIVEN TEMPERATURE, IT RADIATES ENERGY ACROSS A CONTINUOUS SPECTRUM OF WAVELENGTHS WITH MAXIMUM EFFICIENCY. THIS DUALITY OF PERFECT ABSORPTION AND EMISSION MAKES IT AN INDISPENSABLE TOOL FOR PHYSICISTS.

THINK OF IT THIS WAY: A PERFECTLY BLACK PIECE OF VELVET MIGHT SEEM TO ABSORB ALMOST ALL LIGHT, APPEARING TRULY BLACK. HOWEVER, EVEN THIS HIGHLY ABSORPTIVE MATERIAL WILL REFLECT A TINY FRACTION OF LIGHT. A TRUE BLACKBODY, ON THE OTHER HAND, IS A THEORETICAL CONSTRUCT THAT LEAVES NO ROOM FOR SUCH IMPERFECTIONS. IT'S THE ULTIMATE ABSORBER, AND CONSEQUENTLY, IT BECOMES THE ULTIMATE EMITTER OF THERMAL RADIATION WHEN HEATED. THIS PERFECT EMISSIVE PROPERTY IS CRUCIAL BECAUSE IT MEANS THE RADIATION EMITTED BY A BLACKBODY DEPENDS SOLELY ON ITS TEMPERATURE, NOT ON ITS COMPOSITION OR SHAPE, WHICH SIMPLIFIES THEORETICAL MODELS IMMENSELY.

KEY CHARACTERISTICS OF A PERFECT BLACKBODY

SEVERAL DISTINCT CHARACTERISTICS DEFINE A PERFECT BLACKBODY AND DIFFERENTIATE IT FROM ORDINARY OBJECTS. FIRSTLY, AS ALREADY EMPHASIZED, IT ABSORBS ALL INCIDENT ELECTROMAGNETIC RADIATION, REGARDLESS OF FREQUENCY OR ANGLE OF INCIDENCE. THIS MEANS THAT IN A DARK ROOM, A BLACKBODY WOULD APPEAR COMPLETELY INVISIBLE BECAUSE IT WOULDN'T REFLECT ANY AMBIENT LIGHT. SECONDLY, AND PERHAPS MORE IMPORTANTLY FOR PRACTICAL APPLICATIONS, A BLACKBODY IS A PERFECT EMITTER OF THERMAL RADIATION. WHEN HEATED, IT EMITS RADIATION AT ALL WAVELENGTHS, AND THE INTENSITY AND DISTRIBUTION OF THIS RADIATION ARE SOLELY DETERMINED BY ITS ABSOLUTE TEMPERATURE. THIS IS A CRITICAL POINT: THE

SPECTRUM OF RADIATION EMITTED BY A BLACKBODY IS INDEPENDENT OF ITS MATERIAL MAKEUP. THIS UNIVERSALITY ALLOWS SCIENTISTS TO USE BLACKBODY RADIATION AS A STANDARD AGAINST WHICH TO MEASURE THE RADIATION FROM REAL OBJECTS.

ANOTHER IMPORTANT CHARACTERISTIC IS THAT THE RADIATION EMITTED BY A BLACKBODY IS CONTINUOUS, MEANING IT SPANS A BROAD RANGE OF WAVELENGTHS WITHOUT ANY GAPS. THIS CONTINUOUS SPECTRUM IS NOT HAPHAZARD; IT FOLLOWS SPECIFIC MATHEMATICAL LAWS THAT DESCRIBE THE INTENSITY OF RADIATION AT EACH WAVELENGTH. THE TOTAL AMOUNT OF ENERGY RADIATED BY A BLACKBODY IS DIRECTLY PROPORTIONAL TO THE FOURTH POWER OF ITS ABSOLUTE TEMPERATURE, A PRINCIPLE ENCAPSULATED BY THE STEFAN-BOLTZMANN LAW. THE PEAK OF THE EMITTED SPECTRUM, THE WAVELENGTH AT WHICH THE MOST RADIATION IS EMITTED, IS INVERSELY PROPORTIONAL TO ITS TEMPERATURE, AS DESCRIBED BY WIEN'S DISPLACEMENT LAW.

BLACKBODY RADIATION: THE SPECTRUM OF THERMAL ENERGY

THE RADIATION EMITTED BY A BLACKBODY IS KNOWN AS BLACKBODY RADIATION, OR SOMETIMES THERMAL RADIATION. THIS RADIATION IS A DIRECT CONSEQUENCE OF THE THERMAL AGITATION OF CHARGED PARTICLES WITHIN THE OBJECT. AS THE ATOMS AND MOLECULES WITHIN A BODY VIBRATE AND MOVE DUE TO THEIR TEMPERATURE, THEY EMIT ELECTROMAGNETIC WAVES. IN A BLACKBODY, THIS EMISSION PROCESS IS IDEALIZED TO BE PERFECTLY EFFICIENT. THE SPECTRUM OF THIS RADIATION, MEANING HOW THE INTENSITY OF THE EMITTED RADIATION IS DISTRIBUTED ACROSS DIFFERENT WAVELENGTHS, IS OF IMMENSE INTEREST. IT'S NOT A UNIFORM DISTRIBUTION; INSTEAD, IT FOLLOWS A SPECIFIC CURVE THAT CHANGES SHAPE DRAMATICALLY WITH TEMPERATURE.

AT LOW TEMPERATURES, A BLACKBODY EMITS PRIMARILY IN THE INFRARED REGION OF THE ELECTROMAGNETIC SPECTRUM, WHICH IS WHY WE CAN FEEL THE HEAT FROM A WARM OBJECT EVEN IF WE CAN'T SEE IT. AS THE TEMPERATURE INCREASES, THE PEAK OF THE EMITTED SPECTRUM SHIFTS TOWARDS SHORTER WAVELENGTHS, MOVING INTO THE VISIBLE LIGHT RANGE. THIS IS WHY A HEATED PIECE OF METAL FIRST GLOWS RED, THEN ORANGE, YELLOW, AND EVENTUALLY WHITE-HOT AS ITS TEMPERATURE RISES. THE INTENSITY OF THE RADIATION ALSO INCREASES SIGNIFICANTLY WITH TEMPERATURE. THIS SPECTRAL DISTRIBUTION IS NOT ARBITRARY; IT'S GOVERNED BY FUNDAMENTAL LAWS OF PHYSICS, WHICH WE WILL EXPLORE NEXT.

PLANCK'S LAW AND THE QUANTUM REVOLUTION

ONE OF THE MOST SIGNIFICANT BREAKTHROUGHS IN PHYSICS AROSE DIRECTLY FROM THE STUDY OF BLACKBODY RADIATION. FOR DECADES, CLASSICAL PHYSICS STRUGGLED TO ACCURATELY DESCRIBE THE OBSERVED SPECTRUM OF BLACKBODY RADIATION, PARTICULARLY AT SHORTER WAVELENGTHS. CLASSICAL THEORIES PREDICTED THAT THE INTENSITY OF RADIATION SHOULD INCREASE INDEFINITELY AS THE WAVELENGTH GETS SHORTER, A PHENOMENON ALARMINGLY DUBBED THE "ULTRAVIOLET CATASTROPHE." THIS CLEARLY CONTRADICTED EXPERIMENTAL OBSERVATIONS, WHICH SHOWED A PEAK IN THE SPECTRUM AND A DECREASE IN INTENSITY AT VERY SHORT WAVELENGTHS. IT WAS MAX PLANCK IN 1900 WHO, BY MAKING A RADICAL ASSUMPTION, SOLVED THIS PUZZLE.

PLANCK PROPOSED THAT ENERGY IS NOT EMITTED OR ABSORBED CONTINUOUSLY, BUT RATHER IN DISCRETE PACKETS, OR "QUANTA." HE POSTULATED THAT THE ENERGY OF A SINGLE QUANTUM IS DIRECTLY PROPORTIONAL TO THE FREQUENCY OF THE RADIATION, GIVEN BY THE FAMOUS EQUATION $E = hf$, WHERE E IS THE ENERGY, f IS THE FREQUENCY, AND h IS PLANCK'S CONSTANT. THIS REVOLUTIONARY IDEA, THAT ENERGY IS QUANTIZED, LAID THE FOUNDATION FOR QUANTUM MECHANICS. PLANCK'S LAW, DERIVED FROM THIS QUANTIZATION PRINCIPLE, ACCURATELY DESCRIBES THE SPECTRAL DISTRIBUTION OF BLACKBODY RADIATION ACROSS ALL WAVELENGTHS AND AT ANY TEMPERATURE. IT PERFECTLY MATCHES EXPERIMENTAL DATA AND ELEGANTLY RESOLVED THE ULTRAVIOLET CATASTROPHE, USHERING IN A NEW ERA OF PHYSICS.

WIEN'S DISPLACEMENT LAW: PEAK WAVELENGTH AND TEMPERATURE

WHILE PLANCK'S LAW PROVIDES THE COMPLETE SPECTRAL DISTRIBUTION, WIEN'S DISPLACEMENT LAW OFFERS A SIMPLER YET POWERFUL RELATIONSHIP CONCERNING THE PEAK OF THAT DISTRIBUTION. THIS LAW STATES THAT THE WAVELENGTH AT WHICH

THE EMITTED RADIATION IS MOST INTENSE IS INVERSELY PROPORTIONAL TO THE ABSOLUTE TEMPERATURE OF THE BLACKBODY. MATHEMATICALLY, IT'S EXPRESSED AS $\lambda_{\text{MAX}} = b/T$, WHERE λ_{MAX} IS THE PEAK WAVELENGTH, T IS THE ABSOLUTE TEMPERATURE IN KELVIN, AND b IS WIEN'S DISPLACEMENT CONSTANT, APPROXIMATELY 2.898×10^{-3} METER-KELVIN. THIS LAW IS INCREDIBLY USEFUL FOR ESTIMATING THE TEMPERATURE OF DISTANT OBJECTS BASED ON THE COLOR OF THE LIGHT THEY EMIT.

CONSIDER OUR EXAMPLE OF THE HEATED METAL AGAIN. AS IT HEATS UP, THE PEAK WAVELENGTH SHIFTS FROM THE INFRARED TOWARDS VISIBLE LIGHT. A RED GLOW SIGNIFIES A PEAK WAVELENGTH IN THE RED PART OF THE SPECTRUM. AS IT GETS HOTTER, THE PEAK SHIFTS TOWARDS YELLOW, THEN GREEN, AND SO ON. THIS SHIFT IN THE PEAK EMISSION WAVELENGTH WITH TEMPERATURE IS A DIRECT CONSEQUENCE OF WIEN'S DISPLACEMENT LAW. IT'S A FUNDAMENTAL OBSERVATION THAT HELPS US UNDERSTAND HOW TEMPERATURE INFLUENCES THE LIGHT WE PERCEIVE FROM STARS AND OTHER THERMAL SOURCES. THIS PRINCIPLE ALLOWS ASTRONOMERS TO DETERMINE THE SURFACE TEMPERATURES OF STARS JUST BY OBSERVING THEIR COLOR.

THE STEFAN-BOLTZMANN LAW: TOTAL ENERGY EMITTED

ANOTHER CRUCIAL LAW DERIVED FROM THE STUDY OF BLACKBODY RADIATION IS THE STEFAN-BOLTZMANN LAW. THIS LAW QUANTIFIES THE TOTAL AMOUNT OF ENERGY RADIATED PER UNIT SURFACE AREA OF A BLACKBODY AT A GIVEN TEMPERATURE. IT STATES THAT THE TOTAL ENERGY RADIATED IS DIRECTLY PROPORTIONAL TO THE FOURTH POWER OF ITS ABSOLUTE TEMPERATURE. THE EQUATION IS GIVEN BY $P/A = \sigma T^4$, WHERE P/A IS THE POWER RADIATED PER UNIT AREA (ALSO KNOWN AS RADIANT EXITANCE), T IS THE ABSOLUTE TEMPERATURE IN KELVIN, AND σ IS THE STEFAN-BOLTZMANN CONSTANT, APPROXIMATELY $5.670 \times 10^{-8} \text{ W}/(\text{m}^2 \cdot \text{K}^4)$. THIS LAW HIGHLIGHTS THE STRONG DEPENDENCE OF RADIATED ENERGY ON TEMPERATURE; A DOUBLING OF TEMPERATURE RESULTS IN A SIXTEENFOLD INCREASE IN RADIATED POWER.

THIS LAW HAS PROFOUND IMPLICATIONS FOR UNDERSTANDING ENERGY TRANSFER IN VARIOUS SYSTEMS. FOR INSTANCE, IT'S FUNDAMENTAL TO CALCULATING THE ENERGY OUTPUT OF STARS. THE IMMENSE LUMINOSITY OF STARS IS A DIRECT RESULT OF THEIR INCREDIBLY HIGH TEMPERATURES AND VAST SURFACE AREAS, ALL GOVERNED BY THE STEFAN-BOLTZMANN LAW. IT ALSO PLAYS A ROLE IN UNDERSTANDING HEAT TRANSFER IN ENGINEERING APPLICATIONS, FROM DESIGNING FURNACES TO ANALYZING THE THERMAL BALANCE OF SPACECRAFT. THE FACT THAT TEMPERATURE HAS SUCH A POWERFUL INFLUENCE ON RADIATED ENERGY UNDERSCORES WHY TEMPERATURE IS SUCH A CRITICAL FACTOR IN SO MANY PHYSICAL PROCESSES.

REAL-WORLD APPROXIMATIONS OF BLACKBODIES

AS MENTIONED EARLIER, A PERFECT BLACKBODY IS A THEORETICAL CONSTRUCT AND DOESN'T EXIST IN REALITY. HOWEVER, MANY NATURAL AND ARTIFICIAL OBJECTS COME REMARKABLY CLOSE TO BEHAVING LIKE BLACKBODIES. THESE APPROXIMATIONS ARE INCREDIBLY USEFUL BECAUSE WE CAN APPLY THE LAWS OF BLACKBODY RADIATION TO UNDERSTAND THEIR THERMAL EMISSIONS. ONE OF THE BEST REAL-WORLD APPROXIMATIONS IS A CAVITY RADIATOR. IMAGINE A HOLLOW ENCLOSURE WITH A SMALL APERTURE. IF RADIATION ENTERS THIS APERTURE, IT UNDERGOES MULTIPLE REFLECTIONS WITHIN THE CAVITY. MOST OF THE RADIATION IS ABSORBED BY THE WALLS, WITH VERY LITTLE ESCAPING. IF THE APERTURE IS SMALL ENOUGH, THE RADIATION EMERGING FROM IT CLOSELY APPROXIMATES THAT OF A BLACKBODY AT THE TEMPERATURE OF THE CAVITY WALLS.

STARS ARE OFTEN CONSIDERED EXCELLENT APPROXIMATIONS OF BLACKBODIES. THEIR VAST, DENSE PLASMA INTERIORS GENERATE IMMENSE HEAT, AND THEIR SURFACES RADIATE THERMAL ENERGY ACROSS A BROAD SPECTRUM. WHILE STARS HAVE COMPOSITIONS THAT WOULD CAUSE DEVIATIONS FROM PERFECT BLACKBODY BEHAVIOR, THEIR OVERALL RADIATION SPECTRUM IS REMARKABLY WELL-DESCRIBED BY BLACKBODY LAWS. OTHER EXAMPLES INCLUDE THE FILAMENT OF AN INCANDESCENT LIGHT BULB, WHICH, WHILE NOT PERFECT, EMITS LIGHT AND HEAT CONSISTENT WITH BLACKBODY RADIATION AT ITS OPERATING TEMPERATURE. EVEN THE EARTH AND OTHER PLANETS, WHEN CONSIDERED IN ISOLATION FROM EXTERNAL HEAT SOURCES, CAN BE APPROXIMATED AS BLACKBODIES WHEN ANALYZING THEIR THERMAL EMISSIONS INTO SPACE.

APPLICATIONS OF BLACKBODY RADIATION IN SCIENCE AND TECHNOLOGY

THE CONCEPT OF BLACKBODY RADIATION AND ITS GOVERNING LAWS HAVE FAR-REACHING IMPLICATIONS ACROSS NUMEROUS SCIENTIFIC AND TECHNOLOGICAL FIELDS. IN ASTRONOMY, IT IS INDISPENSABLE FOR DETERMINING THE TEMPERATURES OF STARS, NEBULAE, AND OTHER CELESTIAL OBJECTS. BY ANALYZING THE SPECTRUM OF LIGHT RECEIVED FROM THESE DISTANT SOURCES, ASTRONOMERS CAN INFER THEIR SURFACE TEMPERATURES USING WIEN'S DISPLACEMENT LAW AND THEIR ENERGY OUTPUT USING THE STEFAN-BOLTZMANN LAW. THE COSMIC MICROWAVE BACKGROUND RADIATION, A FAINT AFTERGLOW FROM THE BIG BANG, IS AN ALMOST PERFECT BLACKBODY SPECTRUM, PROVIDING CRUCIAL EVIDENCE FOR THE BIG BANG THEORY AND OFFERING INSIGHTS INTO THE EARLY UNIVERSE.

IN THERMAL ENGINEERING, UNDERSTANDING BLACKBODY RADIATION IS VITAL FOR DESIGNING EFFICIENT HEATING AND COOLING SYSTEMS, FURNACES, AND INSULATION. IT'S ALSO FUNDAMENTAL IN FIELDS LIKE SPECTROSCOPY, WHERE MATERIALS ARE ANALYZED BY STUDYING HOW THEY ABSORB AND EMIT RADIATION. MEDICAL IMAGING TECHNOLOGIES, LIKE INFRARED THERMOGRAPHY, UTILIZE THE PRINCIPLES OF THERMAL RADIATION TO DETECT TEMPERATURE VARIATIONS ON THE BODY'S SURFACE, WHICH CAN INDICATE UNDERLYING MEDICAL CONDITIONS. EVEN IN THE DESIGN OF LASERS AND IN UNDERSTANDING THE ENERGY BALANCE OF OUR PLANET, THE PRINCIPLES OF BLACKBODY RADIATION PLAY A SIGNIFICANT ROLE.

FREQUENTLY ASKED QUESTIONS ABOUT BLACKBODIES

Q: WHAT IS THE PRIMARY DIFFERENCE BETWEEN A BLACKBODY AND A REAL-WORLD OBJECT?

A: THE PRIMARY DIFFERENCE IS THAT A BLACKBODY IS AN IDEAL THEORETICAL OBJECT THAT ABSORBS AND EMITS ALL INCIDENT ELECTROMAGNETIC RADIATION PERFECTLY, WITHOUT ANY REFLECTION OR TRANSMISSION. REAL-WORLD OBJECTS ARE IMPERFECT; THEY ABSORB, REFLECT, AND TRANSMIT RADIATION TO VARYING DEGREES, AND THEIR EMISSION SPECTRA DEPEND ON THEIR COMPOSITION AND SURFACE PROPERTIES IN ADDITION TO TEMPERATURE.

Q: WHY IS THE CONCEPT OF A BLACKBODY IMPORTANT IF IT'S AN IDEALIZATION?

A: THE BLACKBODY CONCEPT IS CRUCIAL BECAUSE IT PROVIDES A FUNDAMENTAL BENCHMARK AGAINST WHICH THE RADIATION PROPERTIES OF ALL OTHER OBJECTS CAN BE COMPARED. THE LAWS DERIVED FROM BLACKBODY RADIATION (PLANCK'S LAW, WIEN'S LAW, STEFAN-BOLTZMANN LAW) ARE UNIVERSAL AND ALLOW US TO DEVELOP ACCURATE MODELS AND MAKE PRECISE CALCULATIONS FOR REAL-WORLD PHENOMENA.

Q: CAN A BLACKBODY BE SEEN?

A: IN DARKNESS, A PERFECT BLACKBODY WOULD BE INVISIBLE BECAUSE IT ABSORBS ALL INCIDENT LIGHT AND REFLECTS NONE. HOWEVER, WHEN HEATED, A BLACKBODY EMITS ITS OWN RADIATION ACROSS A SPECTRUM OF WAVELENGTHS. IF THIS EMITTED RADIATION FALLS WITHIN THE VISIBLE SPECTRUM, WE WOULD PERCEIVE IT AS GLOWING WITH A COLOR DETERMINED BY ITS TEMPERATURE, ACCORDING TO WIEN'S DISPLACEMENT LAW.

Q: WHAT IS THE SIGNIFICANCE OF PLANCK'S LAW IN RELATION TO BLACKBODY RADIATION?

A: PLANCK'S LAW IS THE MATHEMATICAL FORMULATION THAT ACCURATELY DESCRIBES THE SPECTRAL DISTRIBUTION OF BLACKBODY RADIATION AT ANY GIVEN TEMPERATURE. IT WAS GROUNDBREAKING BECAUSE IT INTRODUCED THE CONCEPT OF ENERGY QUANTIZATION, WHICH FUNDAMENTALLY CHANGED OUR UNDERSTANDING OF PHYSICS AND PAVED THE WAY FOR QUANTUM MECHANICS.

Q: HOW DOES TEMPERATURE AFFECT THE RADIATION EMITTED BY A BLACKBODY?

A: TEMPERATURE IS THE SOLE DETERMINANT OF THE RADIATION EMITTED BY A BLACKBODY. AS TEMPERATURE INCREASES, THE TOTAL AMOUNT OF ENERGY RADIATED PER UNIT AREA INCREASES SIGNIFICANTLY (STEFAN-BOLTZMANN LAW), AND THE PEAK OF THE EMITTED SPECTRUM SHIFTS TOWARDS SHORTER WAVELENGTHS (WIEN'S DISPLACEMENT LAW).

Q: ARE THERE ANY NATURAL OBJECTS THAT ARE VERY CLOSE TO BEING PERFECT BLACKBODIES?

A: YES, STARS ARE OFTEN CONSIDERED EXCELLENT APPROXIMATIONS OF BLACKBODIES DUE TO THEIR HIGH TEMPERATURES AND DENSE PLASMA COMPOSITION. THE COSMIC MICROWAVE BACKGROUND RADIATION IS ALSO AN ALMOST PERFECT BLACKBODY SPECTRUM.

Q: HOW IS BLACKBODY RADIATION USED IN ASTRONOMY?

A: IN ASTRONOMY, BLACKBODY RADIATION PRINCIPLES ARE USED TO DETERMINE THE SURFACE TEMPERATURES OF STARS AND OTHER CELESTIAL OBJECTS BY ANALYZING THE SPECTRUM OF LIGHT THEY EMIT. IT ALSO HELPS IN UNDERSTANDING THEIR LUMINOSITY AND ENERGY OUTPUT.

Q: WHAT IS THE "ULTRAVIOLET CATASTROPHE," AND HOW WAS IT RESOLVED?

A: THE "ULTRAVIOLET CATASTROPHE" WAS A PREDICTION OF CLASSICAL PHYSICS THAT STATED A BLACKBODY SHOULD EMIT AN INFINITE AMOUNT OF RADIATION AT VERY SHORT WAVELENGTHS (ULTRAVIOLET AND BEYOND). THIS CONTRADICTED EXPERIMENTAL OBSERVATIONS. MAX PLANCK RESOLVED THIS BY PROPOSING THAT ENERGY IS QUANTIZED, A CONCEPT THAT LED TO PLANCK'S LAW, WHICH ACCURATELY DESCRIBES THE OBSERVED SPECTRUM.
