For instance, if an object is moving purely in the x-direction, then in a Cartesian system, v_y and v_z would be zero, simplifying the velocity vector to just $v_x\mathbf{i}$. This focus on relevant components makes analysis much more manageable.

Rotational and Non-Inertial Coordinate Systems: Advanced Concepts
