This spreading is more pronounced when the aperture is very small, especially when its size is comparable to the wavelength of light itself. This bending of light waves around the edges of the aperture is known as diffraction.

Diffraction limits the ultimate resolution of any optical instrument. Even with a perfectly shaped lens and a very large aperture, diffraction will eventually prevent us from seeing infinitely fine detail. The Airy disk, a central bright spot surrounded by faint concentric rings, is the diffraction pattern produced when light passes through a circular aperture. The size of this Airy disk is inversely proportional to the aperture size; a larger aperture produces a smaller Airy disk, leading to better resolution. Therefore, while we strive for larger apertures to gather more light and improve resolution, diffraction acts as a fundamental physical limit.
