DEFINING WORK IN PHYSICS

IN PHYSICS, THE CONCEPT OF "WORK" CARRIES A VERY SPECIFIC MEANING, DISTINCT FROM ITS EVERYDAY USAGE. FOR WORK TO BE DONE, TWO CONDITIONS MUST BE MET: A FORCE MUST BE APPLIED TO AN OBJECT, AND THAT OBJECT MUST MOVE A CERTAIN DISTANCE IN THE DIRECTION OF THE APPLIED FORCE. IF YOU PUSH AGAINST A STATIONARY WALL WITH ALL YOUR MIGHT, YOU MIGHT FEEL EXHAUSTED, BUT ACCORDING TO PHYSICS, YOU'VE DONE NO WORK ON THE WALL BECAUSE IT HASN'T MOVED. IT'S THIS DISPLACEMENT IN THE DIRECTION OF THE FORCE THAT IS KEY. THE MAGNITUDE OF THE WORK DONE IS CALCULATED BY MULTIPLYING THE FORCE APPLIED BY THE DISTANCE OVER WHICH THE FORCE ACTS. MATHEMATICALLY, THIS IS EXPRESSED AS $W = F d$, WHERE W REPRESENTS WORK, F IS THE FORCE, AND d IS THE DISPLACEMENT.

HOWEVER, THE SITUATION BECOMES A LITTLE MORE COMPLEX WHEN THE FORCE IS NOT PERFECTLY ALIGNED WITH THE DIRECTION OF MOTION. IN SUCH CASES, WE ONLY CONSIDER THE COMPONENT OF THE FORCE THAT IS PARALLEL TO THE DISPLACEMENT. THIS IS WHERE TRIGONOMETRY COMES INTO PLAY. IF A FORCE F IS APPLIED AT AN ANGLE θ WITH RESPECT TO THE DISPLACEMENT d , THE WORK DONE IS GIVEN BY $W = F d \cos(\theta)$. THE UNIT OF WORK IN THE INTERNATIONAL SYSTEM OF UNITS (SI) IS THE JOULE (J), NAMED AFTER THE ENGLISH SCIENTIST JAMES PRESCOTT JOULE. ONE JOULE IS DEFINED AS THE WORK DONE WHEN A FORCE OF ONE NEWTON MOVES AN OBJECT ONE METER IN ITS DIRECTION.

FACTORS INFLUENCING WORK DONE

SEVERAL FACTORS DETERMINE THE AMOUNT OF WORK DONE ON AN OBJECT. THE FIRST, AND MOST OBVIOUS, IS THE MAGNITUDE OF THE APPLIED FORCE. A LARGER FORCE APPLIED OVER A DISTANCE WILL RESULT IN MORE WORK BEING DONE. IMAGINE TRYING TO MOVE A HEAVY BOX; THE MORE FORCE YOU EXERT, THE MORE WORK YOU ACCOMPLISH. SECONDLY, THE DISTANCE OVER WHICH THE FORCE ACTS IS CRUCIAL. PUSHING A BOX ACROSS A ROOM REQUIRES MORE WORK THAN PUSHING IT JUST A FEW INCHES. THIRDLY, THE ANGLE BETWEEN THE FORCE AND THE DISPLACEMENT PLAYS A SIGNIFICANT ROLE. IF THE FORCE IS PERPENDICULAR TO THE DISPLACEMENT ($\theta = 90$ DEGREES), THEN $\cos(90^\circ) = 0$, AND NO WORK IS DONE, REGARDLESS OF THE FORCE OR DISTANCE. THIS IS WHY CARRYING A HEAVY SUITCASE HORIZONTALLY AT A CONSTANT SPEED, WHILE EXERTING AN UPWARD FORCE TO COUNTERACT GRAVITY, INVOLVES DOING WORK AGAINST THE FORCE OF GRAVITY (WHICH IS ZERO FOR THE HORIZONTAL MOTION), BUT DOING NO WORK ON THE SUITCASE IN THE VERTICAL DIRECTION OF ITS MOTION.

POSITIVE, NEGATIVE, AND ZERO WORK

THE WORK DONE CAN BE POSITIVE, NEGATIVE, OR ZERO, DEPENDING ON THE RELATIVE DIRECTIONS OF THE FORCE AND DISPLACEMENT. POSITIVE WORK IS DONE WHEN THE FORCE COMPONENT IS IN THE SAME DIRECTION AS THE DISPLACEMENT. FOR EXAMPLE, WHEN YOU LIFT A BOOK UPWARDS, THE APPLIED FORCE AND THE DISPLACEMENT ARE BOTH IN THE UPWARD DIRECTION, RESULTING IN POSITIVE WORK DONE BY YOU ON THE BOOK. NEGATIVE WORK IS DONE WHEN THE FORCE COMPONENT IS IN THE OPPOSITE DIRECTION TO THE DISPLACEMENT. A CLASSIC EXAMPLE IS THE WORK DONE BY FRICTION. WHEN AN OBJECT SLIDES ACROSS A SURFACE, FRICTION OPPOSES ITS MOTION. THEREFORE, THE FORCE OF FRICTION ACTS IN THE OPPOSITE DIRECTION TO THE DISPLACEMENT, RESULTING IN NEGATIVE WORK DONE BY FRICTION. ZERO WORK IS DONE WHEN THE FORCE IS PERPENDICULAR TO THE DISPLACEMENT, OR WHEN THERE IS NO DISPLACEMENT AT ALL, AS IN THE CASE OF PUSHING AGAINST AN UNMOVING WALL.

DEFINING ENERGY IN PHYSICS

ENERGY, IN PHYSICS, IS OFTEN DESCRIBED AS THE "CAPACITY TO DO WORK." IT'S NOT A SUBSTANCE OR A MATERIAL, BUT RATHER A PROPERTY THAT OBJECTS OR SYSTEMS POSSESS. THINK OF IT AS THE FUEL THAT ALLOWS FOR CHANGE AND ACTION. WHEN AN OBJECT HAS ENERGY, IT HAS THE POTENTIAL TO EXERT FORCES AND CAUSE MOTION, THEREBY DOING WORK. ENERGY EXISTS IN MANY DIFFERENT FORMS, AND A KEY PRINCIPLE IN PHYSICS IS THAT ENERGY CAN BE TRANSFERRED FROM ONE OBJECT TO ANOTHER OR TRANSFORMED FROM ONE FORM TO ANOTHER, BUT IT CANNOT BE CREATED OR DESTROYED – THIS IS THE ESSENCE OF THE LAW OF CONSERVATION OF ENERGY.

THE STANDARD UNIT OF ENERGY IN THE SI SYSTEM IS ALSO THE JOULE (J), THE SAME UNIT USED FOR WORK. THIS IS NO COINCIDENCE, AS WORK IS A WAY OF TRANSFERRING ENERGY. WHEN WORK IS DONE ON AN OBJECT, ITS ENERGY INCREASES. CONVERSELY, WHEN AN OBJECT DOES WORK, ITS ENERGY DECREASES. THIS DIRECT RELATIONSHIP HIGHLIGHTS THE FUNDAMENTAL CONNECTION BETWEEN THESE TWO CRUCIAL CONCEPTS IN PHYSICS. UNDERSTANDING ENERGY IS VITAL FOR COMPREHENDING EVERYTHING FROM THE MOTION OF PLANETS TO THE FUNCTIONING OF MICROSCOPIC PARTICLES.

KINETIC ENERGY

KINETIC ENERGY IS THE ENERGY AN OBJECT POSSESSES DUE TO ITS MOTION. THE FASTER AN OBJECT MOVES, AND THE MORE MASSIVE IT IS, THE MORE KINETIC ENERGY IT HAS. THIS IS WHY A SPEEDING BULLET CAN CAUSE SIGNIFICANT DAMAGE, WHILE A STATIONARY BULLET POSES NO THREAT. THE FORMULA FOR KINETIC ENERGY (KE) IS GIVEN BY $KE = \frac{1}{2} m v^2$, WHERE m REPRESENTS THE MASS OF THE OBJECT AND v IS ITS VELOCITY. THIS EQUATION CLEARLY SHOWS THAT KINETIC ENERGY DEPENDS ON THE SQUARE OF THE VELOCITY, MEANING THAT DOUBLING THE SPEED OF AN OBJECT QUADRUPLES ITS KINETIC ENERGY. THIS IS A CRUCIAL INSIGHT WHEN CONSIDERING IMPACTS AND COLLISIONS.

POTENTIAL ENERGY

POTENTIAL ENERGY, ON THE OTHER HAND, IS THE ENERGY AN OBJECT POSSESSES DUE TO ITS POSITION OR CONFIGURATION. IT REPRESENTS STORED ENERGY THAT HAS THE POTENTIAL TO BE CONVERTED INTO OTHER FORMS OF ENERGY, MOST COMMONLY

KINETIC ENERGY. THERE ARE SEVERAL TYPES OF POTENTIAL ENERGY, BUT TWO OF THE MOST COMMON ARE GRAVITATIONAL POTENTIAL ENERGY AND ELASTIC POTENTIAL ENERGY.

GRAVITATIONAL POTENTIAL ENERGY

GRAVITATIONAL POTENTIAL ENERGY (GPE) IS THE ENERGY AN OBJECT HAS BECAUSE OF ITS POSITION IN A GRAVITATIONAL FIELD. THE HIGHER AN OBJECT IS LIFTED AGAINST GRAVITY, THE MORE GRAVITATIONAL POTENTIAL ENERGY IT STORES. FOR AN OBJECT NEAR THE EARTH'S SURFACE, GPE IS CALCULATED AS $GPE = m g h$, WHERE m IS THE MASS, g IS THE ACCELERATION DUE TO GRAVITY (APPROXIMATELY 9.8 m/s^2 ON EARTH), AND h IS THE HEIGHT ABOVE A REFERENCE POINT. A BALL HELD HIGH ABOVE THE GROUND HAS MORE GPE THAN A BALL RESTING ON THE GROUND.

ELASTIC POTENTIAL ENERGY

ELASTIC POTENTIAL ENERGY IS STORED IN ELASTIC MATERIALS WHEN THEY ARE STRETCHED OR COMPRESSED. THINK OF A STRETCHED RUBBER BAND OR A COMPRESSED SPRING. WHEN RELEASED, THIS STORED ENERGY IS CONVERTED INTO KINETIC ENERGY, CAUSING THE MATERIAL TO SNAP BACK TO ITS ORIGINAL SHAPE. THE AMOUNT OF ELASTIC POTENTIAL ENERGY DEPENDS ON THE MATERIAL'S STIFFNESS AND THE EXTENT OF DEFORMATION. FOR A SPRING, IT'S TYPICALLY GIVEN BY $PE_{\text{elastic}} = \frac{1}{2} k x^2$, WHERE k IS THE SPRING CONSTANT (A MEASURE OF STIFFNESS) AND x IS THE DISPLACEMENT FROM THE EQUILIBRIUM POSITION.

FORMS OF ENERGY

ENERGY MANIFESTS IN A DAZZLING ARRAY OF FORMS, EACH WITH ITS UNIQUE CHARACTERISTICS AND APPLICATIONS. UNDERSTANDING THESE VARIOUS FORMS HELPS US APPRECIATE THE PERVASIVENESS AND ADAPTABILITY OF ENERGY IN THE UNIVERSE. FROM THE VASTNESS OF STELLAR PROCESSES TO THE INTRICATE WORKINGS OF OUR OWN BODIES, ENERGY IS THE DRIVING FORCE BEHIND EVERY CHANGE AND PHENOMENON WE OBSERVE.

- **THERMAL ENERGY:** THIS IS THE ENERGY ASSOCIATED WITH THE RANDOM MOTION OF ATOMS AND MOLECULES WITHIN A SUBSTANCE. IT'S WHAT WE COMMONLY REFER TO AS HEAT. THE HOTTER AN OBJECT, THE MORE ITS PARTICLES ARE VIBRATING AND MOVING, AND THUS, THE GREATER ITS THERMAL ENERGY.
- **CHEMICAL ENERGY:** STORED WITHIN THE BONDS OF ATOMS AND MOLECULES, CHEMICAL ENERGY IS RELEASED OR ABSORBED DURING CHEMICAL REACTIONS. THE FOOD WE EAT, THE FUELS WE BURN, AND THE BATTERIES THAT POWER OUR DEVICES ALL STORE AND UTILIZE CHEMICAL ENERGY.
- **ELECTRICAL ENERGY:** THIS IS THE ENERGY ASSOCIATED WITH THE FLOW OF ELECTRIC CHARGE, TYPICALLY ELECTRONS, THROUGH A CONDUCTOR. IT'S THE ENERGY THAT POWERS OUR HOMES, LIGHTS OUR CITIES, AND RUNS OUR ELECTRONIC GADGETS.
- **RADIANT ENERGY:** THIS FORM OF ENERGY TRAVELS IN ELECTROMAGNETIC WAVES, SUCH AS VISIBLE LIGHT, RADIO WAVES, X-RAYS, AND GAMMA RAYS. THE SUN IS A PRIMARY SOURCE OF RADIANT ENERGY FOR EARTH, PROVIDING LIGHT AND HEAT.
- **NUCLEAR ENERGY:** THIS IS THE ENERGY STORED WITHIN THE NUCLEUS OF AN ATOM, RELEASED DURING NUCLEAR REACTIONS LIKE FISSION (SPLITTING OF ATOMS) OR FUSION (COMBINING OF ATOMS). IT'S THE POWER SOURCE OF STARS AND IS HARNESSSED IN NUCLEAR POWER PLANTS.
- **SOUND ENERGY:** THIS IS ENERGY THAT TRAVELS AS MECHANICAL WAVES THROUGH A MEDIUM (LIKE AIR OR WATER) DUE TO VIBRATIONS. WHEN YOU SPEAK, YOUR VOCAL CORDS VIBRATE, CREATING SOUND WAVES THAT CARRY ENERGY TO THE LISTENER'S EARS.

THE WORK-ENERGY THEOREM

THE WORK-ENERGY THEOREM IS A FUNDAMENTAL PRINCIPLE THAT ELEGANTLY CONNECTS THE CONCEPTS OF WORK AND KINETIC ENERGY. IT STATES THAT THE NET WORK DONE ON AN OBJECT IS EQUAL TO THE CHANGE IN ITS KINETIC ENERGY. IN SIMPLER TERMS, IF YOU WANT TO INCREASE AN OBJECT'S SPEED (AND THEREFORE ITS KINETIC ENERGY), YOU MUST DO WORK ON IT. CONVERSELY, IF AN OBJECT DOES WORK, ITS KINETIC ENERGY MUST DECREASE.

MATHEMATICALLY, THE WORK-ENERGY THEOREM IS EXPRESSED AS $W_{\text{net}} = \Delta KE$, WHERE W_{net} IS THE NET WORK DONE ON THE OBJECT AND ΔKE IS THE CHANGE IN KINETIC ENERGY ($KE_{\text{final}} - KE_{\text{initial}}$). THIS THEOREM IS INCREDIBLY POWERFUL BECAUSE IT ALLOWS US TO CALCULATE THE CHANGE IN AN OBJECT'S MOTION WITHOUT NEEDING TO KNOW ALL THE INDIVIDUAL FORCES ACTING ON IT OR ITS PRECISE ACCELERATION OVER TIME. WE ONLY NEED TO KNOW THE NET WORK DONE.

IMPLICATIONS OF THE THEOREM

THE IMPLICATIONS OF THE WORK-ENERGY THEOREM ARE FAR-REACHING. IT PROVIDES A MORE DIRECT WAY TO ANALYZE MOTION, ESPECIALLY IN SITUATIONS INVOLVING MULTIPLE FORCES. FOR INSTANCE, IF YOU'RE PUSHING A BOX ACROSS A FLOOR, THERE ARE FORCES LIKE YOUR PUSH, FRICTION, AND POSSIBLY AIR RESISTANCE. CALCULATING THE WORK DONE BY EACH OF THESE FORCES AND SUMMING THEM UP TO FIND THE NET WORK GIVES US THE TOTAL CHANGE IN THE BOX'S KINETIC ENERGY. THIS THEOREM IS PARTICULARLY USEFUL WHEN DEALING WITH PROBLEMS WHERE FORCES ARE NOT CONSTANT OR WHERE THE PATH OF MOTION IS COMPLEX.

CONSIDER A PROJECTILE LAUNCHED INTO THE AIR. AS IT ASCENDS, GRAVITY DOES NEGATIVE WORK ON IT, REDUCING ITS KINETIC ENERGY AND THUS ITS SPEED. AS IT DESCENDS, GRAVITY DOES POSITIVE WORK, INCREASING ITS KINETIC ENERGY AND SPEED. THE WORK-ENERGY THEOREM ALLOWS US TO UNDERSTAND THESE TRANSFORMATIONS OF ENERGY DUE TO THE ACTION OF FORCES.

APPLICATIONS AND REAL-WORLD EXAMPLES

THE PRINCIPLES OF WORK AND ENERGY ARE NOT CONFINED TO TEXTBOOKS AND LABORATORIES; THEY ARE WOVEN INTO THE FABRIC OF OUR EVERYDAY LIVES AND THE OPERATION OF COUNTLESS TECHNOLOGIES. FROM THE SIMPLEST ACT OF WALKING TO THE COMPLEX MECHANICS OF SPACE TRAVEL, WORK AND ENERGY ARE CONSTANTLY AT PLAY.

THINK ABOUT RIDING A BICYCLE. WHEN YOU PEDAL, YOU ARE APPLYING A FORCE TO THE PEDALS, AND THE WHEELS ARE TURNING, CAUSING THE BICYCLE TO MOVE FORWARD. YOU ARE DOING WORK ON THE BICYCLE, INCREASING ITS KINETIC ENERGY AS IT SPEEDS UP. AIR RESISTANCE AND FRICTION ARE FORCES THAT OPPOSE THIS MOTION, DOING NEGATIVE WORK AND CONVERTING SOME OF THE KINETIC ENERGY INTO HEAT. WHEN YOU GO DOWNHILL WITHOUT PEDALING, GRAVITY DOES POSITIVE WORK, CONVERTING YOUR GRAVITATIONAL POTENTIAL ENERGY INTO KINETIC ENERGY, MAKING YOU GO FASTER.

ANOTHER EXCELLENT EXAMPLE IS A ROLLER COASTER. AT THE TOP OF THE HIGHEST HILL, THE ROLLER COASTER CAR POSSESSES A LARGE AMOUNT OF GRAVITATIONAL POTENTIAL ENERGY. AS IT DESCENDS, THIS POTENTIAL ENERGY IS CONVERTED INTO KINETIC ENERGY, ALLOWING IT TO REACH HIGH SPEEDS. THE TRACK EXERTS AN UPWARD FORCE ON THE CAR, DOING WORK THAT CHANGES THE DIRECTION OF MOTION BUT NOT ITS SPEED SIGNIFICANTLY (IDEALLY, NEGLECTING FRICTION). THE INTRICATE INTERPLAY OF FORCES AND ENERGY TRANSFORMATIONS IS WHAT MAKES ROLLER COASTERS SO THRILLING.

ENERGY IN EVERYDAY TASKS

EVEN SEEMINGLY SIMPLE TASKS INVOLVE WORK AND ENERGY. LIFTING GROCERIES FROM THE GROUND TO YOUR KITCHEN COUNTER INVOLVES DOING WORK AGAINST GRAVITY, INCREASING THE GRAVITATIONAL POTENTIAL ENERGY OF THE GROCERIES. PUSHING A LAWNMOWER REQUIRES YOU TO EXERT A FORCE OVER A DISTANCE, DOING WORK AND INCREASING THE MOWER'S KINETIC ENERGY. THE ENERGY YOU EXPEND COMES FROM THE CHEMICAL ENERGY STORED IN YOUR BODY, WHICH IS CONVERTED INTO MECHANICAL WORK.

TECHNOLOGICAL APPLICATIONS

IN THE REALM OF TECHNOLOGY, WORK AND ENERGY ARE PARAMOUNT. ENGINES IN CARS CONVERT THE CHEMICAL ENERGY STORED IN FUEL INTO MECHANICAL WORK THAT PROPELS THE VEHICLE. POWER PLANTS HARNESS VARIOUS FORMS OF ENERGY (NUCLEAR, FOSSIL FUELS, SOLAR, WIND) AND CONVERT THEM INTO ELECTRICAL ENERGY, WHICH IS THEN TRANSMITTED TO OUR HOMES AND BUSINESSES. CRANES LIFT HEAVY LOADS BY DOING WORK AGAINST GRAVITY, STORING POTENTIAL ENERGY IN THE LIFTED OBJECTS. EVEN IN TINY ELECTRONIC DEVICES, THE FLOW OF ELECTRICAL ENERGY IS WHAT ALLOWS THEM TO FUNCTION.

CONSERVATION OF ENERGY

PERHAPS THE MOST PROFOUND AND UNIVERSALLY APPLICABLE PRINCIPLE RELATED TO ENERGY IS THE LAW OF CONSERVATION OF ENERGY. THIS LAW STATES THAT IN AN ISOLATED SYSTEM, THE TOTAL AMOUNT OF ENERGY REMAINS CONSTANT; IT CANNOT BE CREATED OR DESTROYED, ONLY TRANSFORMED FROM ONE FORM TO ANOTHER. THIS IS A CORNERSTONE OF PHYSICS AND HAS FAR-REACHING IMPLICATIONS FOR OUR UNDERSTANDING OF THE UNIVERSE.

CONSIDER A PENDULUM SWINGING. AT ITS HIGHEST POINT, IT HAS MAXIMUM POTENTIAL ENERGY AND MINIMUM KINETIC ENERGY. AS IT SWINGS DOWNWARDS, ITS POTENTIAL ENERGY DECREASES, AND ITS KINETIC ENERGY INCREASES. AT THE LOWEST POINT OF ITS SWING, IT HAS MINIMUM POTENTIAL ENERGY AND MAXIMUM KINETIC ENERGY. IF WE IGNORE AIR RESISTANCE AND FRICTION, THE SUM OF ITS POTENTIAL AND KINETIC ENERGY REMAINS CONSTANT THROUGHOUT THE SWING. THIS CONSTANT SUM IS OFTEN REFERRED TO AS MECHANICAL ENERGY.

THE ROLE OF FRICTION AND DISSIPATION

IN REAL-WORLD SCENARIOS, HOWEVER, SYSTEMS ARE RARELY PERFECTLY ISOLATED. FRICTION, AIR RESISTANCE, AND OTHER DISSIPATIVE FORCES ARE ALMOST ALWAYS PRESENT. THESE FORCES DO NEGATIVE WORK, CONVERTING MECHANICAL ENERGY INTO THERMAL ENERGY (HEAT) AND SOUND ENERGY. WHILE THE TOTAL ENERGY OF THE UNIVERSE IS CONSERVED, THE MECHANICAL ENERGY OF A SPECIFIC SYSTEM MAY APPEAR TO DECREASE DUE TO THESE DISSIPATIVE PROCESSES. HOWEVER, THIS LOST MECHANICAL ENERGY HASN'T VANISHED; IT HAS MERELY TRANSFORMED INTO LESS USEFUL FORMS OF ENERGY THAT SPREAD OUT INTO THE ENVIRONMENT.

UNDERSTANDING ENERGY CONSERVATION HELPS US ANALYZE COMPLEX SYSTEMS AND PREDICT THEIR BEHAVIOR. IT'S CRUCIAL FOR DESIGNING EFFICIENT MACHINES, UNDERSTANDING NATURAL PHENOMENA, AND DEVELOPING SUSTAINABLE ENERGY SOLUTIONS. THE PRINCIPLE ASSURES US THAT ENERGY IS A FINITE, YET INCREDIBLY VERSATILE, RESOURCE THAT WE CAN MANAGE AND TRANSFORM, BUT NEVER TRULY LOSE.

THE UNWAVERING PRINCIPLE OF CONSERVATION OF ENERGY, IN PARTICULAR, OFFERS A PROFOUND INSIGHT INTO THE FUNDAMENTAL NATURE OF THE UNIVERSE – THAT ENERGY, IN ITS MYRIAD FORMS, IS AN ENDURING QUANTITY. MASTERING THE CONCEPTS OF WORK AND ENERGY EQUIPS YOU WITH A POWERFUL TOOLKIT FOR UNDERSTANDING NOT JUST PHYSICS, BUT THE DYNAMIC PROCESSES THAT SHAPE OUR REALITY. AS YOU CONTINUE TO EXPLORE THE PHYSICAL WORLD, REMEMBER THAT EVERY ACTION, EVERY TRANSFORMATION, IS A STORY TOLD IN THE LANGUAGE OF WORK AND ENERGY.

FAQ

Q: WHAT IS THE DIFFERENCE BETWEEN WORK AND ENERGY IN PHYSICS?

A: IN PHYSICS, WORK IS DEFINED AS THE TRANSFER OF ENERGY THAT OCCURS WHEN A FORCE CAUSES AN OBJECT TO MOVE A CERTAIN DISTANCE. ENERGY, ON THE OTHER HAND, IS THE CAPACITY TO DO WORK. ENERGY IS THE PROPERTY THAT ALLOWS THIS ACTION TO OCCUR.

Q: IS THERE WORK DONE IF I HOLD A HEAVY OBJECT STATIONARY?

A: NO, ACCORDING TO THE PHYSICS DEFINITION OF WORK, NO WORK IS DONE IF YOU HOLD A HEAVY OBJECT STATIONARY. WHILE YOU EXERT A FORCE AND MAY FEEL TIRED, WORK REQUIRES DISPLACEMENT IN THE DIRECTION OF THE FORCE. SINCE THE OBJECT IS NOT MOVING, THERE IS NO DISPLACEMENT, AND THEREFORE NO WORK IS DONE.

Q: WHAT IS THE PRIMARY UNIT FOR MEASURING WORK AND ENERGY IN PHYSICS?

A: THE PRIMARY UNIT FOR MEASURING BOTH WORK AND ENERGY IN THE INTERNATIONAL SYSTEM OF UNITS (SI) IS THE JOULE (J). ONE JOULE IS EQUIVALENT TO THE WORK DONE WHEN A FORCE OF ONE NEWTON MOVES AN OBJECT A DISTANCE OF ONE METER IN THE DIRECTION OF THE FORCE.

Q: CAN ENERGY BE LOST OR DESTROYED?

A: NO, ACCORDING TO THE LAW OF CONSERVATION OF ENERGY, ENERGY CANNOT BE CREATED OR DESTROYED. IT CAN ONLY BE TRANSFORMED FROM ONE FORM TO ANOTHER OR TRANSFERRED FROM ONE SYSTEM TO ANOTHER. FOR EXAMPLE, CHEMICAL ENERGY IN FUEL IS TRANSFORMED INTO THERMAL AND KINETIC ENERGY IN A CAR ENGINE.

Q: HOW DOES KINETIC ENERGY CHANGE WITH SPEED?

A: KINETIC ENERGY CHANGES WITH THE SQUARE OF THE SPEED. THE FORMULA FOR KINETIC ENERGY IS $KE = \frac{1}{2} m v^2$, WHERE m IS MASS AND v IS VELOCITY. THIS MEANS IF YOU DOUBLE THE SPEED OF AN OBJECT, ITS KINETIC ENERGY INCREASES BY A FACTOR OF FOUR.

Q: WHAT IS THE WORK-ENERGY THEOREM?

A: THE WORK-ENERGY THEOREM STATES THAT THE NET WORK DONE ON AN OBJECT IS EQUAL TO THE CHANGE IN ITS KINETIC ENERGY. THIS THEOREM PROVIDES A DIRECT RELATIONSHIP BETWEEN THE WORK PERFORMED ON AN OBJECT AND ITS RESULTING CHANGE IN MOTION.

Q: GIVE AN EXAMPLE OF NEGATIVE WORK BEING DONE.

A: AN EXAMPLE OF NEGATIVE WORK IS THE WORK DONE BY FRICTION. WHEN AN OBJECT SLIDES ACROSS A SURFACE, THE FORCE OF FRICTION OPPOSES THE MOTION. THEREFORE, THE FRICTION FORCE ACTS IN THE OPPOSITE DIRECTION TO THE OBJECT'S DISPLACEMENT, RESULTING IN NEGATIVE WORK DONE BY FRICTION.

Q: HOW IS POTENTIAL ENERGY DIFFERENT FROM KINETIC ENERGY?

A: KINETIC ENERGY IS THE ENERGY OF MOTION, WHILE POTENTIAL ENERGY IS STORED ENERGY DUE TO AN OBJECT'S POSITION OR CONFIGURATION. FOR INSTANCE, A MOVING CAR HAS KINETIC ENERGY, WHILE A CAR PARKED AT THE TOP OF A HILL HAS
