- **RESEARCHER** – THOSE INTERESTED IN ACADEMIA MAY PURSUE RESEARCH POSITIONS, CONTRIBUTING TO THE UNDERSTANDING OF CRIMINAL BEHAVIOR AND EFFECTIVE INTERVENTIONS.
- **PROFESSOR OR EDUCATOR** – WITH ADVANCED DEGREES, INDIVIDUALS CAN TEACH AT UNIVERSITIES, SHAPING THE NEXT GENERATION OF FORENSIC PSYCHOLOGY PROFESSIONALS.
