UNDERSTANDING CONDITIONS OF WORTH

- **APPROVAL CONDITIONS:** SEEKING VALIDATION FROM OTHERS CAN LEAD PEOPLE TO FEEL VALUABLE ONLY WHEN THEY RECEIVE EXTERNAL APPROVAL.

UNDERSTANDING THESE VARIOUS CONDITIONS IS CRUCIAL FOR RECOGNIZING HOW THEY SHAPE IDENTITY AND SELF-PERCEPTION.

THE ROLE OF CONDITIONS OF WORTH IN SELF-ESTEEM

SELF-ESTEEM IS SIGNIFICANTLY INFLUENCED BY CONDITIONS OF WORTH. WHEN INDIVIDUALS INTERNALIZE THESE CONDITIONS, THEIR SELF-WORTH BECOMES FRAGILE AND DEPENDENT ON EXTERNAL VALIDATION. THIS OFTEN LEADS TO CYCLES OF SELF-CRITICISM AND INSECURITY.

CYCLE OF CONDITIONAL SELF-WORTH

1. **EXTERNAL VALIDATION:** INDIVIDUALS SEEK APPROVAL FROM OTHERS, OFTEN MODIFYING THEIR BEHAVIOR TO GAIN IT.

4. **REINFORCEMENT OF CONDITIONS:** THIS CYCLE PERPETUATES AS INDIVIDUALS CONTINUE TO SEEK VALIDATION, REINFORCING THEIR CONDITIONS OF WORTH.

IMPACT ON MENTAL HEALTH

CONDITIONS OF WORTH IN RELATIONSHIPS
