THE QUALITY OF THEMATIC ANALYSIS CAN VARY SIGNIFICANTLY DEPENDING ON THE RESEARCHER'S SKILLS AND EXPERIENCE. INCONSISTENT APPLICATION OF THE PROCESS MAY LEAD TO UNRELIABLE RESULTS, EMPHASIZING THE NEED FOR RIGOROUS TRAINING AND ADHERENCE TO ESTABLISHED GUIDELINES.

APPLICATIONS OF THEMATIC ANALYSIS IN PSYCHOLOGICAL RESEARCH
