HISTORY OF WISCONSIN PSYCHOLOGY ASSOCIATION

THE WISCONSIN PSYCHOLOGY ASSOCIATION (WPA) WAS ESTABLISHED IN THE EARLY 20TH CENTURY AS A RESPONSE TO THE GROWING NEED FOR A UNIFIED BODY THAT COULD REPRESENT THE INTERESTS OF PSYCHOLOGISTS IN THE STATE.
