MOREOVER, PSYCHOLOGICAL THEORIES SUGGEST THAT RISK-TAKERS ARE OFTEN MOTIVATED BY THE POTENTIAL REWARDS ASSOCIATED WITH THEIR ACTIONS, WHICH CAN INCLUDE SOCIAL RECOGNITION, EXCITEMENT, AND PERSONAL FULFILLMENT.

ENVIRONMENTAL INFLUENCES ON RISK-TAKING

THE ENVIRONMENT ALSO SHAPES RISK-TAKING BEHAVIORS.
