THE EXECUTIVE BRANCH

THE ROLE OF THE PRESIDENT

THE JUDICIAL BRANCH

- SUPREME COURT OF THE UNITED STATES
- U.S. COURTS OF APPEALS (CIRCUIT COURTS)
- U.S. DISTRICT COURTS

THE SUPREME COURT HAS THE ULTIMATE AUTHORITY IN INTERPRETING THE CONSTITUTION AND FEDERAL LAW, WHILE LOWER COURTS HANDLE CASES INVOLVING FEDERAL LAW, DISPUTES BETWEEN STATES, AND MORE.

FUNCTIONS OF THE JUDICIAL BRANCH

THE PRIMARY FUNCTIONS OF THE JUDICIAL BRANCH INCLUDE:

- INTERPRETING LAWS AND DETERMINING THEIR CONSTITUTIONALITY.
