IF YOU ARE COMFORTABLE EXPRESSING YOURSELF CLEARLY, ACTIVELY LISTENING TO OTHERS, AND NAVIGATING DIVERSE PERSONALITIES WITH TACT AND DIPLOMACY, YOU ARE WELL-EQUIPPED FOR THE COMMUNICATION DEMANDS OF THE LEGAL PROFESSION.

## INTEGRITY AND ETHICAL CONDUCT

### THE COMPETITIVE LANDSCAPE

A: THE MOST CRITICAL SKILLS INCLUDE STRONG ANALYTICAL AND CRITICAL THINKING, EXCELLENT WRITTEN AND VERBAL COMMUNICATION, EXCEPTIONAL RESEARCH ABILITIES, PROBLEM-SOLVING APTITUDE, RESILIENCE, AND A HIGH DEGREE OF ETHICAL INTEGRITY.
