UPDATES TO THE REFERENCE LIST FORMAT

CHANGES TO FORMATTING AND BIAS-FREE LANGUAGE

MASTERING IN-TEXT CITATIONS IN APA 7TH EDITION

IN-TEXT CITATIONS ARE THE BACKBONE OF THE APA 7TH EDITION CITATION STYLE, PROVIDING IMMEDIATE ATTRIBUTION TO SOURCES WITHIN THE BODY OF YOUR PAPER. THESE BRIEF REFERENCES DIRECT READERS TO THE MORE DETAILED ENTRIES IN YOUR REFERENCE LIST, ALLOWING THEM TO VERIFY YOUR INFORMATION AND EXPLORE THE ORIGINAL SOURCES.

AUTHOR-DATE SYSTEM FOR IN-TEXT CITATIONS

THE CORE OF APA'S IN-TEXT CITATION SYSTEM IS THE AUTHOR-DATE FORMAT. WHETHER YOU ARE PARAPHRASING OR DIRECTLY QUOTING, YOU WILL TYPICALLY INCLUDE THE AUTHOR'S LAST NAME AND THE YEAR OF PUBLICATION. FOR DIRECT QUOTES, A PAGE NUMBER OR OTHER SPECIFIC LOCATOR IS ALSO REQUIRED.

- **PARENTHETICAL CITATION:** THE INFORMATION APPEARS IN PARENTHESES AT THE END OF THE SENTENCE OR CLAUSE. EXAMPLE: (SMITH, 2020). FOR A DIRECT QUOTE: (JONES, 2019, p. 45).
- **NARRATIVE CITATION:** THE AUTHOR'S NAME IS INCORPORATED INTO THE SENTENCE, WITH THE YEAR OF PUBLICATION FOLLOWING IN PARENTHESES. EXAMPLE: ACCORDING TO MILLER (2021), THIS PHENOMENON IS SIGNIFICANT. FOR A DIRECT QUOTE: MILLER (2021) STATED, "THE RESULTS WERE CONCLUSIVE" (p. 12).

CITING MULTIPLE AUTHORS AND CORPORATE AUTHORS

AS MENTIONED, FOR SOURCES WITH THREE OR MORE AUTHORS, USE "ET AL." FOR ALL IN-TEXT CITATIONS, EVEN THE FIRST ONE (E.G., JOHNSON ET AL., 2022). FOR CORPORATE AUTHORS OR ORGANIZATIONS, CITE THE FULL NAME THE FIRST TIME, THEN ABBREVIATE IF THE ABBREVIATION IS COMMON AND WILL NOT CONFUSE THE READER (E.G., AMERICAN PSYCHOLOGICAL ASSOCIATION [APA], 2023; THEN APA, 2023).

HANDLING DIRECT QUOTES VS. PARAPHRASED MATERIAL

WHILE BOTH REQUIRE IN-TEXT CITATIONS, DIRECT QUOTES DEMAND EXTRA CARE. THEY MUST BE ENCLOSED IN QUOTATION MARKS, AND A PAGE NUMBER (OR PARAGRAPH NUMBER FOR UNPAGINATED SOURCES) MUST BE PROVIDED. PARAPHRASED MATERIAL, ON THE RE-EXPRESSION OF ANOTHER'S IDEAS IN YOUR OWN WORDS, STILL REQUIRES AN AUTHOR-DATE CITATION BUT DOES NOT NEED A PAGE NUMBER, THOUGH PROVIDING ONE CAN BE HELPFUL FOR READERS ACCESSING LENGTHY WORKS.

BUILDING A COMPREHENSIVE APA 7TH EDITION REFERENCE LIST

THE REFERENCE LIST, APPEARING AT THE END OF YOUR PAPER, PROVIDES COMPLETE BIBLIOGRAPHICAL INFORMATION FOR EVERY SOURCE CITED IN YOUR TEXT. IT ALLOWS READERS TO LOCATE AND RETRIEVE THE SOURCES YOU CONSULTED. ADHERING TO THE SPECIFIC FORMATTING RULES FOR EACH SOURCE TYPE IS A CRITICAL ASPECT OF THE APA 7TH EDITION CITATION STYLE.

GENERAL PRINCIPLES OF THE REFERENCE LIST

THE REFERENCE LIST SHOULD BEGIN ON A NEW PAGE, TITLED "REFERENCES" (CENTERED AND BOLD). ENTRIES ARE LISTED ALPHABETICALLY BY THE FIRST AUTHOR'S LAST NAME. EACH ENTRY MUST HAVE A HANGING INDENT (THE FIRST LINE IS FLUSH LEFT, AND SUBSEQUENT LINES ARE INDENTED 0.5 INCHES). THE ENTIRE REFERENCE LIST SHOULD BE DOUBLE-SPACED.

KEY ELEMENTS OF A REFERENCE ENTRY

WHILE THE EXACT FORMAT VARIES BY SOURCE TYPE, MOST REFERENCE ENTRIES SHARE COMMON ELEMENTS, OFTEN REFERRED TO AS THE "WHO, WHAT, WHEN, WHERE" OF THE SOURCE:

1. **AUTHOR:** WHO CREATED THE WORK? (LAST NAME, INITIALS.)
2. **DATE:** WHEN WAS THE WORK PUBLISHED? (YEAR, MONTH DAY FOR SOME SOURCES.)
3. **TITLE:** WHAT IS THE TITLE OF THE WORK? (ITALICIZED FOR STAND-ALONE WORKS LIKE BOOKS OR JOURNAL TITLES; REGULAR FONT FOR ARTICLES.)
4. **SOURCE:** WHERE CAN THE WORK BE RETRIEVED? (JOURNAL NAME, VOLUME, ISSUE, PAGE RANGE, PUBLISHER, URL, OR DOI.)

FORMATTING SPECIFIC SOURCE TYPES IN APA 7TH EDITION

JOURNAL ARTICLES ARE A CORNERSTONE OF ACADEMIC RESEARCH. THE FORMAT FOR AN ONLINE JOURNAL ARTICLE WITH A DOI (DIGITAL OBJECT IDENTIFIER) IS: AUTHOR, A. A., AUTHOR, B. B., & AUTHOR, C. C. (YEAR). *TITLE OF ARTICLE*. *TITLE OF PERIODICAL*, *VOLUME*(*ISSUE*), *PAGES*. DOI: xxxxxxxxxxxx

EXAMPLE: WENZEL, T. A. (2021). THE IMPACT OF DIGITAL LITERACY ON STUDENT SUCCESS. *JOURNAL OF EDUCATIONAL TECHNOLOGY*, 15(2), 123-145. [HTTPS://DOI.ORG/10.1234/JET.2021.015.02.123](https://doi.org/10.1234/jet.2021.015.02.123)

BOOKS AND E-BOOKS

FOR A BOOK: AUTHOR, A. A. (YEAR). *TITLE OF WORK* (EDITION, IF APPLICABLE). PUBLISHER.

EXAMPLE: GOLD, M. (2018). *THE PSYCHOLOGY OF MOTIVATION* (3RD ED.). ACADEMIC PRESS.

FOR AN E-BOOK: AUTHOR, A. A. (YEAR). *TITLE OF WORK* (EDITION, IF APPLICABLE). PUBLISHER. URL OR DOI

EXAMPLE: CHEN, L. (2019). *UNDERSTANDING COGNITIVE DEVELOPMENT*. ROUTLEDGE.

WEBSITES CAN BE TRICKIER DUE TO VARYING LEVELS OF INFORMATION. THE BASIC FORMAT IS: AUTHOR, A. A. (YEAR, MONTH DAY). *TITLE OF WEBPAGE*. SITE NAME. URL

EXAMPLE: AMERICAN PSYCHOLOGICAL ASSOCIATION. (2023, SEPTEMBER 15). *APA STYLE GUIDELINES*.

IF NO SPECIFIC AUTHOR, USE THE ORGANIZATION AS THE AUTHOR. IF NO DATE, USE "(N.D.)" FOR "NO DATE."

OTHER COMMON SOURCES

THE 7TH EDITION ALSO PROVIDES SPECIFIC GUIDANCE FOR:

- **REPORTS:** SIMILAR TO BOOKS, OFTEN INCLUDING REPORT NUMBERS.
- **CONFERENCE PROCEEDINGS:** INCLUDES DETAILS ABOUT THE CONFERENCE.
- **THESES AND DISSERTATIONS:** SPECIFY IF UNPUBLISHED OR FROM A DATABASE.
- **VIDEOS AND PODCASTS:** INCLUDES CREATOR, DATE, TITLE, AND PLATFORM.

BEYOND CITATIONS: GENERAL FORMATTING RULES

WHILE CITATIONS ARE CENTRAL, THE APA 7TH EDITION CITATION STYLE ENCOMPASSES A BROADER SET OF FORMATTING RULES THAT GOVERN THE OVERALL APPEARANCE AND STRUCTURE OF AN ACADEMIC PAPER. THESE GUIDELINES CONTRIBUTE TO THE PROFESSIONAL PRESENTATION AND READABILITY OF YOUR SCHOLARLY WORK.

PAPER COMPONENTS AND STRUCTURE

AN APA PAPER TYPICALLY INCLUDES A TITLE PAGE, AN ABSTRACT (FOR PROFESSIONAL PAPERS), THE MAIN BODY (INTRODUCTION, METHODS, RESULTS, DISCUSSION), AND A REFERENCE LIST. OPTIONAL ELEMENTS INCLUDE AN AUTHOR NOTE, FOOTNOTES, TABLES, AND FIGURES. THE 7TH EDITION OFFERS DISTINCT TITLE PAGE FORMATS FOR STUDENT PAPERS (INCLUDING COURSE NUMBER, INSTRUCTOR, AND DUE DATE) AND PROFESSIONAL PAPERS (WITH AN AUTHOR NOTE AND RUNNING HEAD).

PROPER USE OF HEADINGS HELPS READERS NAVIGATE YOUR DOCUMENT AND UNDERSTAND ITS STRUCTURE, REFLECTING THE COMPREHENSIVE NATURE OF THE APA 7TH EDITION CITATION STYLE.

FONT, SPACING, AND MARGINS

A: THE PRIMARY PURPOSE OF THE APA 7TH EDITION CITATION STYLE IS TO PROVIDE A STANDARDIZED FRAMEWORK FOR ACADEMIC WRITING, FORMATTING, AND SOURCE ATTRIBUTION, PARTICULARLY IN THE SOCIAL SCIENCES. Q: How do in-text citations differ between the APA 6th and 7th editions for multiple authors?

A: In the APA 7th edition, for sources with three or more authors, you use "et al." for all in-text citations, including the first one (e.g., Smith et al., 2020). In contrast, the APA 6th edition required listing all authors for the first citation for three to five authors, before using "et al." for subsequent citations.

Q: Do I still need to include "Retrieved from" for URLs in the APA 7th edition reference list?

A: No, generally you do not need to include "Retrieved from" before a URL in the APA 7th edition reference list. This phrase is typically only used if a retrieval date is necessary because the source material is likely to change over time, such as for a specific entry in an online dictionary or a live stream.

Q: What are the key elements required for a basic reference list entry in APA 7th edition?

A: The key elements for a basic reference list entry in APA 7th edition, often called the "who, what, when, where," are: Author(s) (who), Date of publication (when), Title of the work (what), and Source information (where it can be retrieved, e.g., journal name, publisher, URL, or DOI).
