4. **HARVARD STYLE:** A GENERIC TERM FOR AN AUTHOR-DATE REFERENCING SYSTEM, COMMONLY USED IN ECONOMICS AND NATURAL SCIENCES, WITH VARIATIONS IMPLEMENTED BY DIFFERENT UNIVERSITIES.

- **USE SPECIFIC DATA OR STATISTICS:** ANY NUMERICAL DATA, STATISTICS, OR UNIQUE FACTS DERIVED FROM A SOURCE MUST BE CITED.
- **INCORPORATE IMAGES, TABLES, OR FIGURES:** VISUAL ELEMENTS NOT CREATED BY YOU REQUIRE A CAPTION AND A SOURCE CITATION.

THE "HOW" DEPENDS ON THE CITATION STYLE. TYPICALLY, AN IN-TEXT CITATION (E.G., AUTHOR-DATE OR AUTHOR-PAGE) POINTS TO A MORE COMPLETE ENTRY IN A BIBLIOGRAPHY OR REFERENCE LIST AT THE END OF YOUR DOCUMENT. ENSURE THAT EVERY IN-TEXT CITATION HAS A CORRESPONDING FULL ENTRY IN YOUR REFERENCE LIST, AND VICE VERSA. OVER-CITING IS GENERALLY PREFERABLE TO UNDER-CITING WHEN IN DOUBT.

EFFECTIVE PARAPHRASING AND SUMMARIZING TECHNIQUES

BEYOND DIRECT QUOTATION AND CITATION, MASTERING THE ART OF EFFECTIVE PARAPHRASING AND SUMMARIZING IS A CORNERSTONE FOR HOW TO AVOID PLAGIARISM DETECTION SOFTWARE. DISTINGUISHING PARAPHRASING FROM DIRECT QUOTATION

IT IS CRUCIAL TO UNDERSTAND THE CLEAR DISTINCTION BETWEEN PARAPHRASING AND DIRECT QUOTATION TO PROPERLY INTEGRATE SOURCES AND MAINTAIN ORIGINALITY. PARAPHRASING, ON THE OTHER HAND, MEANS RESTATING ANOTHER AUTHOR'S IDEA OR INFORMATION IN YOUR OWN WORDS, MAINTAINING THE ORIGINAL MEANING, BUT USING ENTIRELY NEW SENTENCE STRUCTURES AND VOCABULARY. EVEN WHEN PARAPHRASING, YOU MUST PROVIDE A CITATION FOR THE SOURCE OF THE IDEA. THE PURPOSE OF PARAPHRASING IS TO CLARIFY A POINT, SIMPLIFY COMPLEX INFORMATION, OR INTEGRATE A SOURCE'S IDEA SEAMLESSLY INTO YOUR OWN ARGUMENT WITHOUT INTERRUPTING THE FLOW OF YOUR WRITING WITH A DIRECT QUOTE. PLAGIARISM DETECTION SOFTWARE WILL OFTEN FLAG PARAPHRASED CONTENT THAT IS TOO CLOSE TO THE ORIGINAL SOURCE, EVEN WITHOUT EXACT WORD MATCHES, IF THE STRUCTURAL SIMILARITY IS TOO HIGH.
