EXAM STRUCTURE AND TOPICS

THE EXAM IS COMPRISED OF 80 QUESTIONS IN TOTAL, WITH 40 QUESTIONS DEDICATED TO NATIONAL REAL ESTATE PRINCIPLES AND PRACTICES, AND 40 QUESTIONS FOCUSED ON TEXAS-SPECIFIC REAL ESTATE LAWS AND REGULATIONS. THE FOLLOWING TOPICS ARE TYPICALLY COVERED:

JOINING A STUDY GROUP

ENGAGING WITH PEERS CAN PROVIDE ADDITIONAL SUPPORT AND MOTIVATION. A STUDY GROUP ALLOWS YOU TO DISCUSS CHALLENGING TOPICS, QUIZ EACH OTHER, AND SHARE STUDY RESOURCES, FACILITATING A DEEPER UNDERSTANDING OF THE MATERIAL.

COMMON PITFALLS TO AVOID

TIPS FOR EXAM DAY

ON THE DAY OF THE EXAM, YOUR PREPARATION WILL BE PUT TO THE TEST. FOLLOWING SPECIFIC STRATEGIES CAN HELP YOU PERFORM AT YOUR BEST.

ARRIVE EARLY

GIVE YOU TIME TO RELAX AND MENTALLY PREPARE BEFORE THE TEST.

READ QUESTIONS CAREFULLY

DURING THE EXAM, TAKE YOUR TIME TO READ EACH QUESTION CAREFULLY. PAY ATTENTION TO KEYWORDS AND PHRASES, AS THEY CAN SIGNIFICANTLY ALTER THE MEANING OF THE QUESTION.

MANAGE YOUR TIME

THE EXAM IS TIMED, SO IT'S ESSENTIAL TO KEEP AN EYE ON THE CLOCK. IF YOU ENCOUNTER A DIFFICULT QUESTION, MARK IT AND MOVE ON. YOU CAN ALWAYS RETURN TO IT LATER IF TIME PERMITS.

FREQUENTLY ASKED QUESTIONS

Q: WHAT IS THE PASSING SCORE FOR THE TEXAS REAL ESTATE EXAM?

A: THE PASSING SCORE FOR THE TEXAS REAL ESTATE EXAM IS 70%. CANDIDATES MUST CORRECTLY ANSWER AT LEAST 56 OF THE 80 QUESTIONS.

Q: HOW MUCH DOES IT COST TO TAKE THE TEXAS REAL ESTATE EXAM?

A: THE FEE TO TAKE THE TEXAS REAL ESTATE EXAM IS TYPICALLY AROUND \$60, BUT THIS MAY VARY DEPENDING ON THE TESTING PROVIDER.
